#### **Executive summary**

Title of policy or decision: Community Dementia Support Services procurement

Describe the main aims, objectives and purpose of the policy (or decision): To obtain Cabinet approval and agreement to approach the market to invite submission of bids to the proposed procurement process for a Family Navigation Service and Community Support Service for citizens living with dementia and their care givers. Family Navigation, Information and Support – providing more co-ordinated access to information and support that enables people to adapt to a life with dementia will ensure individuals and families have the knowledge, confidence and support networks to live independently and manage any crisis, but equally have access to timely intervention when required.

Community programme – strengthening the response of the entire community to dementia by developing the entire community - including retailers and service providers – to ensure that their businesses and services are inclusive to people living with the condition; will ensure people are able to continue to live they life they want to lead and remain as physically and emotionally active for as long as possible.

Dementia Coordinator within the Community Response Programme contract that enables the development of partnerships and works towards building dementia friendly communities.

Use this section to record how you have assessed any potential impact on the communities likely to be affected by the policy (or decision): The UK population is ageing; people are living longer and as a result the number of people experiencing ill health and being diagnosed with long term health conditions, such as dementia, is growing, with further growth predicted.

In Essex alone, 30,000 people currently have a diagnosis of Dementia, and this is projected to increase by 156% in the next 30 years. The estimate is that by 2050 there will be an 73,800 people with dementia in Essex. Within this overall increase, those considered to fall within the oldest (aged 90+) category are expected to increase from current levels of around 4,200 to 9,200 by 2034.

Currently, 10% of total Adult Social Care spend is on dementia diagnosis (which includes primary and secondary records of dementia). This spend only represents 18% of the total number of people living with dementia in Essex, therefore the expectation is that the total spend will increase going forward. Over half of people living with dementia, supported by ECC, are in residential care and a further 7% in nursing care.

Nationally, dementia, (including mental health), remains one of the NHS' biggest spend.
