Item 4.1 (DR/30/23) Castledon School, Bromfords Drive, Wickford, Essex SS12 0PW

Page 42 – BACKGROUND

New 2nd paragraph: In March 2022 Basildon Borough Council granted planning permission for the construction of a sports hall with associated storage and changing facilities, hard and soft landscaping and external plant enclosure (21/01450/FULL). This permission has not been implemented.

Page 42 – SITE

New 3rd paragraph: "The main school buildings were constructed in the late 1960's. The Oriel building was granted planning permission in 2008 (CC/BAS/123/08). The temporary classbases, which would be removed as part of these proposals, have been on the site school for a number of years (ranging from the 1980s to 2003). The temporary classbase which is to be retained on site was granted planning permission in 2012 (CC/BAS/19/12).

Page 59 – DESIGN, LAYOUT AND SUSTAINABILITY

The County's Sustainable Travel team has advised that a number of school streets have been implemented in the area including Bromfords Drive, which provides access to Castledon School. A 20mph speed limit and temporary street art together with speed adjustment cushions/raised tables at nearby junctions would also be implemented in the area for the start of the 2023 Autumn term.

In September 2023 the Sustainable Travel team will be engaging with the local school community (including Castledon School, Bromfords School and Grange Primary School) to understand the issues on the local streets, the barriers to active travel and solutions that could be implemented. This work is scheduled to be completed for September 2024.
