Executive summary

Title of policy / **decision:** New Section 75 Partnership Agreement with Essex Partnership University NHS Foundation Trust for Mental Health Social Work.

Policy / decision type: Cabinet Member Action (CMA)

Overview of policy / decision: Forward plan reference : FP/469/07/22

The Council's duties under the Care Act 2014 for residents of Essex with mental health needs have been delegated to the NHS under Section 75 of the NHS Act 2006. These duties are currently carried out on the Council's behalf by Essex Partnership University NHS Foundation Trust ("the Trust"). The existing Partnership Agreement, referred to as the Section 75 Agreement, expires on 30th September 2022. Under this Agreement, most of the Council's mental health social work workforce are embedded within the Trust's operational services and is managed by the Trust.

The associated CMA seeks agreement for a continuation of the existing satisfactory arrangement with EPUT (Essex Partnership University Trust). In addition, a full review and redesign of the mental health social work operational model is being conducted in tandem with the NHS England Community Mental Health Transformation Programme. This review also includes the Council's Mental Health and Wellbeing Team, which sits outside the Section 75 Agreement under the direct management of the Council, but excludes the *AMHP Service which is being reviewed as part of a separate project.

The associated CMA is seeking agreement to enter into a new Section 75 Agreement with the Trust for a period of 2 years and six months, ending on 31st March 2025. The Agreement is to start from the expiry of the current Agreement on 30th September 2022. The new agreement will contain several changes compared to the existing agreement, that in part updates the agreement to reflect the most up to date arrangements, and in part allows for additional anticipated changes during the period of the agreement. These changes will be as a result of the full review and redesign of mental health social work operating model. The changes will be aimed at creating significantly improved services in the future. In addition, this review is being undertaken in tandem with other partners across the system with the aim of potentially enabling new forms of 'fit for purpose' governance to be put in place from 1st April 2025.

*Approved Mental Health Professionals Service is the service responsible for the assessment of individuals under the Mental health Act 1983 (as Amended by MHA 2007).

What outcome(s) are you hoping to achieve?: A new Section 75 Partnership Agreement with the Trust will provide the required time to enable a full review and redesign of mental health social work operational model to be undertaken and implemented.

The outcome of the new S75 Agreement and the review will contribute to all five of the health commitments in Everyone's Essex: healthy lifestyles, promoting independence, place-based working, increasing the support of carers, and levelling up health.

The review of the operational delivery of the Mental Health Social Work Services has the broad overarching

ambition to deliver better mental health services across the whole spectrum of need. Therefore, the scope of the review includes both specialist mental health as well as the development of a stronger prevention and early intervention offer, that can reduce or delay the onset of mental health needs and promote recovery in line with the duties for Local Authorities contained within the Care Act 2014. Our aspiration is about widening the care and support that is available to mental health in a way that recognises the wider determinants and causes of poor mental health. This will contribute to the Council commitment to reduce health inequalities.

In addition, the review and redesign includes a commitment to co-production with people with lived experience and family carers as part of the review. Stakeholders will be asked for their opinion on proposed changes to Operational delivery model for Social Work Services and specifically whether they think the changes will better meet their needs.

The review and redesigned model will also be complementary to the ASC Place Based model and this is aimed at delivering services to service users that take into account specific locality needs and so they are to be delivered close to where the users live.

How will the impact of the policy / decision be monitored and evaluated?: Monitoring

The existing S75 monitoring arrangements will remain and be enhanced, with monthly meetings to review budget, performance, quality and learning metrics, as agreed in the relevant schedules of the new Section 75 agreement. These will be chaired by the ASC Director for MH Operations. It is understood by the Trust and the Council that during the new 30-month Partnership Agreement (and as the Review & Redesign project work evolves) new metrics and reporting is likely to be required.

As part of the full review and redesign of mental health social work services the above monthly monitoring and performance data will be supplemented with deep dives and audits into specific areas to obtain qualitative information as well as quantitive data about the services to give a more rounded view of the impact of any proposed changes.

The review is being conducted in Partnership with EPUT and the overall programme is overseen by a monthly Joint Steering Group (JSG) that reports to the S75 Partnership Board which is accountable to the Adults Leadership Team in the Council and to the Trust Executive Team. The JSG will monitor and track the review and redesign project.

Evaluation

The decision whether to put a further Section 75 Agreement in place (or an alternative form of governance) after the new 30-month Agreement will be evaluated by reference to the delivery of the expected improvements in mental health social work services during the period of the new agreement. This will be carried out by the JSG, reporting to the ECC Adult Leadership Team and the Trust Executive Team.

Rationale for assessment, including data used to assess the impact: The decision to put in place a new Section 75 agreement in itself will have a positive impact by strengthening the oversight that ECC has over the services provided to the population who use them. In addition, the decision will provide time to undertake a full review and redesign of mental health social care operating model with the aim of working to develop services that broaden access to people that may require them across the eligible population of Essex; those aged primarily between 18-64yrs old (ONS data list this population as 870,804), but with further consideration of those transitioning from children's services to ASC, adults over the age of 64 who have complex MH needs; and those with other complex needs, including Learning Disabilities.

As part of the review project and redesign consideration will be given to how the Council and Trust could collect a more richer data set of service user information, including those with protected characteristics.

It should be noted that although it is anticipated that changes to the organisation and operational delivery of mental health social care will be made during the period of the new agreement, a longer period of time than the duration of the agreement is likely to be needed to fully evaluate the impact of changes to the Operational Model for social work.

The services will effect all cohorts of the population and geographic areas.

The Review and redesign include a commitment to co-production with people with lived experience, and family carers as part of the review, including those groups that maybe more difficult to engage with. Stakeholders will be asked for their opinion on proposed changes to Operational delivery model for Social Work Services and specifically whether they think proposed changes will better meet their needs.

As part of the review Social Workers will be educated on the availability of personal computing facilities located in Essex libraries so that service users who do not have access to such facilities at home can access MH services.
