	 Furthermore, you believe a benefit of the restrictions would make easier turning for vehicles, in particular larger vehicles such as refuse lorries and goods delivery vehicles. If you look again at the site plan for Little Berry Lane it can be seen that with or without parking restrictions it is impossible for a large vehicle to turn, The yellow lines currently in place, if they remain, will restrict homeowners and their visitors parking outside their own homes in Little Berry Lane, indeed, the lines will restrict any parking some 15 metres from the crossovers. This distance seems to be far greater than any cyclist would need. The crossovers are used regularly by cyclists, motorcyclists and pedestrians, access from the Little Berry Lane side is always clear. I accept that there was a breakdown in your internal communications and that the yellow lines have already been installed. I hope that you now consider that these restrictions are unnecessary. 	manoeuvring. We could have been clearer in our statement of reasons that this additional benefit only really affects Great Berry Lane and Great Berry Farm Chase. • Essex Highways explained It is inevitable reducing parking space in a road via the use of a No Waiting at Any Time restriction will mean there are less places for households with multiple vehicles to park, however, Little Berry Lane benefits from two parking lay-bys more than capable of accommodating two family sized vehicles each. This makes Little Berry Lane well provisioned with on street parking, much more so than other areas. • Essex Highways explained that residents have been advised that their comments have been taken on board and that these double yellow lines are not yet enforceable.

- path/pedestrian access between the two roads is not blocked. I would like to point out that pedestrian access is not in question; the path on both sides of the road, is in no way affected by parked cars. There is a bollard in the centre of the path, on either side of the scenic area; cars cannot park on the path, and pedestrians can walk through without obstruction.
- The lines are painted across our driveway, in front of the scenic area/greenery, and across the driveway of our neighbour opposite. On the 'Little Berry Lane' side of the scenic area/greenery installed in 1989 to prevent through traffic, our driveway and that of our neighbour opposite are immediately adjacent to the path/cycle path; consequently, the path and cycle path can never be blocked, as any car blocking them would also be blocking access to our properties. On the opposite side of the scenic area, at the top of Great Berry Lane I have noticed that cars sometimes park in front of the greenery, and outside the front of no. 196 alongside the grass verge. This doesn't impact on our neighbours in Great Berry Lane, as they can still access their driveway, but I appreciate if parked without outside their own homes, they will have to park outside
