Executive summary

Title of policy or decision: Optimisation of Essex Housing – creation of Essex Housing Group Limited Liability Partnership

Describe the main aims, objectives and purpose of the policy (or decision): Essex Housing is a development arm of Essex County Council that works with public sector partners across Essex to identify and bring forward surplus land in order to help address general, specialist and affordable housing need, generate capital receipts and deliver revenue benefits.

Essex Housing has successfully delivered a number of housing schemes. Based on learning to date it is clear there is an opportunity to deliver even greater benefits more efficiently through improving Essex Housing's operating arrangements and establishing a Limited Liability Partnership (LLP) structure.

A Decision is being sought to:

- establish the LLP structure to provide Essex County Council with greater financial flexibility (it will enable ECC to have the flexibility to use any surpluses to fund capital or revenue expenditure which is not permitted in its current structure).
- establish new governance and operational processes for Essex Housing, to increase pace, scale and efficiency.
- enable ECC to be able to retain units for rent where required in order to generate new revenue streams, provide units to help meet specific ECC requirements and provide greater resilience in the event there is a downturn in the housing market.
