The Sub-Committee considered report SC/002/11 by the Monitoring Officer regarding an allegation of misconduct made against Essex County Councillor Brian Wood. The Sub-Committee were asked to determine whether there had

been a breach of the Essex Member Code of Conduct and, if so, to determine what sanction, if any, should be given.

The Sub-Committee noted the pre-hearing summary.

The Sub-Committee did not dispute any of the findings of fact and agreed that County Councillor Brian Wood had breached Paragraph 3(1) of the Code of Conduct in that he had failed to treat Mr Pharro with respect after a meeting of the Canvey Island East Neighbourhood Meeting on 4 November 2010 by speaking inappropriately.

In accordance with the agreed Procedure the Sub-Committee then considered what sanction if any should be given to Councillor Wood. The Sub-Committee took into consideration that Councillor Wood had already sent a letter of apology to Mr Pharro.

#### Resolved:

- That County Councillor Brian Wood had breached Paragraph 3(1) of the Code of Conduct in that he had failed to treat Mr Pharro with respect after a meeting of the Canvey Island East Neighbourhood Meeting on 4 November 2010 by speaking inappropriately, be agreed; and
- 2. That a letter be sent to Councillor Wood conveying the Sub-Committee's disappointment concerning his behaviour and requesting that he ensure that his language is more temperate in future
