Note: Governor appointment/elections are conditional upon application for, and receipt of, a satisfactory DBS check. Where the check is not satisfactory the appointment/election will not be confirmed. For re-appointments, where a governor was elected or appointed before 1st April 2016 and does not hold an enhanced criminal record certificate, the governing body must apply for such a certificate in respect of that governor by 1st September 2016.

### 4. Options

- 4.1 Re-appoint or appoint the nominated candidates as set out in the Schedule as the Local Authority Governor. These appointments will ensure that there is full representation at the school. This is the preferred option.
- 4.2 Do not re-appoint or appoint the nominate candidates as the Local Authority Governor. This will result in the Local Authority being under represented, and will require a further recruitment process to source alternative nominees.
