Executive summary

Title of policy or decision: Commissioning the new model for Mental Health Supported Accommodation in Essex

Describe the main aims, objectives and purpose of the policy (or decision): Mental Health Supported Accommodation is part of the wider Mental Health programme, providing support for those people with a primary mental health need who require support to rebuild their daily living skills.

The new model for Mental Health Supported Accommodation has been developed through partnership with those with lived experience and colleagues in the wider system. The new model will deliver a more diverse range of accommodation and support solutions for those with mental health conditions to reduce reliance on traditional hospital care and promote admission prevention and recovery.

The present decision will enable ECC to go ahead, in partnership with Health colleagues and the mental health trust, and commission new services from October 2022. The model will be phased in across Essex, with the full model going live in North-East and West Essex initially and current service provision being recommissioned in Mid and South Essex. The Mid and South Essex Health system hope to be able to work with Essex County Council to implement the new model over the coming three years.

Assessing the equality impact

Use this section to record how you have assessed any potential impact on the communities likely to be affected by the policy (or decision): Essex County Council provides supported accommodation for people with mental health needs. The legislative framework for the provision of such services lay within s117 of the Mental Health Act 1983, which places a duty for health and local authorities to provide health and social care support for those leaving hospital or other institutional settings, and the Care Act 2014, which requires local authorities to assess adults who may have eligible care and support needs and ensure these needs are met.

Safe, secure and stable housing is central to people's health and wellbeing, and this is especially so for people coping with poor mental health. Commissioners work closely with people who are experts by experience, who are clear that the elements most important in their recovery and continued wellness are "having decent places to live (i.e. their own front door), meaningful, purposeful things to do (which could be employment), social networks, good relationships and a sense of belonging within their communities". These fundamental principles are central

to our commissioning. The Mental Health Supported Accommodation services provide support within accommodation for people with mental health needs. These Supported Housing services enable the Council and the CCGs to discharge their statutory duties for local residents with mental health needs. The support provided delivered in these services helps in meeting individuals' assessed needs in a manner that enables their recovery pathway and the move into independent living in the wider community.

In developing the new model, we have worked with people who have lived experience, both by through taking their thoughts and what does and does not work currently and through testing and designing the new approach with them. This has enable us to develop a new model which is truly co-produced by those who have experienced supported accommodation and mental health challenges for themselves.

For those with the most complex needs there will be specialist provision which will support their recovery. There will be an improvement in training opportunities for staff which will support improved recovery in the medium and low levels of provision as people transition towards independent living.

Please provide more details about the extent of impact: The positive impact will be medium. The new model will reconfigure provision to address the gaps in current provision for those people with complex needs, address issues of throughput and move on into general needs accommodation and work with key partners (Suppliers, Health and Local Housing Partners) to take a whole system approach, which will be to the benefit of those

suffering with poor mental health and with an assessed need for supported accommodation. It will ensure that people are in the most appropriate accommodation for their needs, recovering in the least restrictive way possible.
