1. Methodology

Where there have been local authority boundary changes, we have used the same ASC RNF allocation shares as those in the Department for Levelling Up, Housing and Communities (DLUHC) [final local government finance settlement for 2021 to 2022](https://www.gov.uk/government/collections/final-local-government-finance-settlement-england-2021-to-2022) (<https://www.gov.uk/government/collections/final-local-government-finance-settlement-england-2021-to-2022>).

This applies to the local authority geography changes in April 2019 (Dorset, and Bournemouth, Christchurch and Poole unitary authorities) and in April 2021 (North Northamptonshire and West Northamptonshire unitary authorities).
