### **Executive summary**

**Title of policy or decision:** Direct Award of the Integrated Community Equipment Service (ICES)

**Describe the main aims, objectives and purpose of the policy (or decision):** Equipment Service (ICES) is provided by both health and social care to allow the frail, elderly and physically disabled to live independently in their own home. The service delivered 138,000 items of

equipment to in excess of 66,566 service users within the areas of Essex County Council (ECC) and Thurrock Council in 2018/19.

The award being sought incorporates a direct award to ECL to 31st March 2023, with the possibility of a two year extension. This will ensure continuity of service for all those using the provision. The service will continue integration between health and social care under a Section 75 arrangement for the duration of the requested contract award. ECC currently hosts the Equipment Services contract on behalf of ECC, Thurrock Council, a number of NHS clinical commissioning

groups (Castle Point and Rochford, Basildon and Brentwood, Thurrock, Mid Essex and Mid Essex Hospital Trust and East Suffolk North Essex NHS Foundation Trust. The current contract value is £12,700,000

The contract will not change eligibility for the service, and is designed to improve the experience for the end user with innovations and developments implemented throughout the life of the contract.
