#### **Executive summary**

**Title of policy or decision:** Approval of the investment of £255,840 to ensure legal compliance of accessibility regulations. The Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018 (the Regulations) which came into force on September 2018. The aim of the Regulations is to ensure public sector websites and mobile applications are accessible to all users, especially those with disabilities

Describe the main aims, objectives and purpose of the policy (or decision): Essex County Council need to procure a digital partner to build capability within the organisation to develop skills within teams to ensure websites are compliant and meet accessibility standards. The contract will be no longer than 12 months as Essex County Council (ECC) will be expected to manage accessibility compliance within the organisation from September 2020.

Secure specialist skills are required that are not currently in house, these include; content rewriting and technical redesign of websites, ensuring ECC is self-sustaining in maintaining website accessibility on an ongoing basis.

The regulations are clear that any failure to comply will be seen as a failure to make reasonable adjustments as set out under the Equality Act 2010.

ECC requires funding to ensure compliance with the regulations, this will include procuring a digital partner and securing specialist skills to meet the requirements by September 2020.

robust' for all users. This can be achieved by making sure it meets the international accessibility standard, WCAG 2.1 AA or its European equivalent, EN301 549

• Publish an accessibility statement - ECC has published this on the ECC Website https://www.essex.gov.uk/accessibility

The resources required to deliver this project will, in part, be met through existing staff that have the necessary skills and knowledge to make the required changes to website code and content. In addition to this, increased organisational capacity and capability is required to address and maintain accessibility standards; this is planned to be met through the procurement of a digital accessibility partner and recruitment of a skilled team to deliver the enhancements required to the website and wider applications to ensure that the accessibility requirements are met.

ECC only has a handful of permanent staff that understand accessibility compliance and have the necessary skills to make changes to website code and content. Procuring the support of an accessibility partner will mean that we are able to increase organisational capability and capacity to address and maintain accessibility standards. Building capability within the organisation will enable ECC to move towards modernisation of Services and meet our Strategic priorities.

ECC needs to procure the right tools and training to ensure that the organisation has the right capability to identify and fix issues. Staff in Service Design, Communications and Marketing and Technology Services need an in-depth knowledge of digital accessibility. Services managing their own websites need to understand how to make their content accessible and Service Heads need to understand the importance of digital access.
