Update on the work of the Essex Safeguarding Children Board

Introduction

This paper and attached information sets out the presentation to be provided to the Essex People and Families Scrutiny Committee in February 2018.

Presentation

The presentation will focus on current priorities and how these are being worked on and progressed, as opposed to reflection on the previous year. It will cover the following:

• Introduction to the Board- structure, responsibilities, linkages with the County Council and impact of the Children and Social Work Act

- Summary of key areas of work of the Board and its effectiveness
- Child Exploitation as an example of ongoing work

We would be interested in views and comments from Members on the Board's current work and priorities.

Summary of presentation and key points:

Statutory framework and structure of the ESCB

The Board exists as a statutory body and has a range of roles including developing policies and procedures and scrutinising and challenging local safeguarding practice.

Section 14 of the Children Act 2004 sets out the objectives for a Local Safeguarding Children Board as:

- To coordinate what is done by each person or body represented on the Board for the purposes of safeguarding and promoting the welfare of children in the area and;
- To ensure the effectiveness of what is done by each such person or body for these purposes.

The Safeguarding Children Board does not deal with individual cases except when it is carrying out reviews such as Serious Case Reviews. The Board works with its member organisations and a range of public sector providers and commissioners to raise the standard of multi agency working – it does not intervene in operational matters or cases.

The role of the Safeguarding Children Board is to have an independent coordinating and challenge role around safeguarding practice across its partner agencies. This is carried out by the Sub-committees and working groups of the ESCB, which are:

- Child Death Overview Panel (statutory)
- Serious Case Review (statutory)
- Learning and Development (joint with Essex Safeguarding Adults Board (ESAB))
- Communications (joint with Essex Safeguarding Adults Board)
- Performance, Audit and Quality Assurance
- Policies, Procedures & Practice Development and a joint Southend, Essex and Thurrock (SET) Policies and Procedures group
- Child Sexual Exploitation and Missing and a SET Strategic Exploitation Group
- Health Executive Forum involving directors of nursing from all NHS commissioners and providers in Essex.
- District, City and Borough Councils Group including safeguarding leads from

all 12 councils

Essex County Council (ECC) is represented on the ESCB Executive via senior officers as ECC is one of the partner agencies of the Board.

Revised governance following the Children and Social Work Act 2017.

The ESCB undertook a governance review in 2016/17 following publication of the Wood Review and the subsequent Children and Social Work Act 2017 removing the statutory footing for LSCBs but nevertheless requiring multi agency safeguarding arrangements to be in place. These revised governance arrangements were put in place from April 2017 onwards with key changes being that of even more direct links to local practice via the Stay Safe Groups, a smaller Executive Board including our Health, Police and Social Care partners as recommended under the Wood Review and also continued involvement with our other partners via the Assembly. The structure chart is attached. The four Stay Safe Groups are quadrant based and allow agency leads in those areas to meet and discuss local operational safeguarding issues.

Annual report and effectiveness

Business Plan

The work of the Board is set out in its Business Plan (see attached) and the effectiveness of this is reviewed in its Annual Report. The ESCB Business Plan 2017 – 19 continues to focus on understanding what impact has been made to the lives of children, young people and their families as a result of interventions/services by agencies. This plan includes the following areas of work:

- Assessing the impact of multi agency working to tackle Domestic Abuse where children are involved.
- Raising the profile of Neglect
- Focus on child sexual exploitation, gangs, youth offending
- Evaluating the impact and provision of early help arrangements including thresholds and families moving into Essex County Council area
- Monitoring and evaluating the provision of mental health support for children and young people including any lessons learned from a thematic review of

deaths of young people in Essex.

• Focussing on partnership working to ensure that risks are identified, lessons learned and good practice is embedded to make sure that children and young people are safeguarded.

The Board agenda is very wide and the following is a topical example of how the Board carries out its role in Essex.

Child Exploitation

This is an example of work by the ESCB to tackle the issues of exploitation.

Child sexual exploitation (CSE) has become a national priority following a number of high profile cases which hit public and media attention over the last 8 years raising failings in multi-agency arrangements to tackle CSE and drove forward a focus to develop robust responses to this issue to ensure such failings could be addressed. CSE is not a new phenomenon but our understanding and knowledge about how exploitation occurs and the impact of such abuse on children, young people and families has become better understood. Sexual exploitation is child abuse, and predominantly involves the coercion, manipulation of a child to sexual activities in exchange for something the child needs or wants, and/or for the financial advantage or increased status of the perpetrator or facilitator. The victim may have been sexually exploited even if the sexual activity appears consensual. Child sexual exploitation does not always involve physical contact; it can also occur through the use of technology.

Partnership arrangements to tackle child exploitation is complex as it requires the commitment of not only our statutory, charitable and voluntary agencies but also a whole community approach including county, city, district and borough councils, the private sector and the general public. CSE Champions were created over 4 years ago to build a network of professionals covering the breadth of partnership working to ensure that individual teams/agencies had someone available to support them in understanding their responsibilities around CSE and to spread learning and development internally within their organisations. In 2017 there were over 600 CSE Champions trained across Essex.

The Essex Safeguarding Children Board instigated and approved multi-agency missing and child exploitation meetings across Essex in early 2016 to ensure that all agencies are routinely reviewing risk and vulnerability in relation to children that are known or at risk of exploitation and trafficking. These meetings are delivered in 4 quadrants of Essex on a monthly basis and are well attended from across the partnership; they have supported a clearer picture of the threats to children and young people within the borders, and travelling across the borders of Essex. Part of what we now know, and of growing interest nationally, is the wider forms of exploitation that are prevalent, such as criminal exploitation of children (CCE), in


which children are coerced, manipulated or threatened into criminal activities. CCE often involves exploiting children to transport or supply drugs, including Class A drugs within or outside of the county and is often associated with gangs or county lines activities.

This clearer understanding has allowed for strategic action plans and operational responses to prioritise all forms of exploitation to children and to build public facing campaigns across Southend, Essex and Thurrock that outline how to spot the signs of abuse and where to report concerns. The <u>| Didn't Know CSE Campaign</u> was launched in 2016 and relaunched again in 2017. Inspired by a video project designed and created by the Essex Children in Care Council, it aims to raise awareness about CSE across the wider Essex area and support communities understanding of what CSE is, how to recognise it, and what to do to get help and support. To date this campaign has reached over 2 million people via social media, the supporting <u>campaign video</u> has been shown in cinemas to support engagement directly with children, young people and families. A wide range of resources have been created for this campaign, including posters, leaflets, videos, case studies, as well as materials for taxi licensing and licensed premises. Parents can access the ESCB campaign page which has been created to inform parents and carers of how to spot the signs and where to go for help if they are worried, this also includes a leaflet which they can print off. Whilst we have significantly grown in our partnership responsibilities to tackling child exploitation over the years, there is much more that can be done and is continuing to be done, including; working directly with educational establishments to hear the voices of young people in relation to exploitation; providing age appropriate resources for schools so they can deliver information to young people; and working with our transport networks including British Transport Police to ensure we are responding to children that are exploited or go missing and use our public transport networks, such as rail links through **Operation Henderson.**

A commitment by all councils and organisations across Essex to continue with these developments is required and an understanding that whilst exploitation can happen to any child in any community, perpetrators often seek out the most vulnerable children.

Essex Safeguarding Children Board (ESCB) 2016-17 THE HEADLINES

This summary is based on the ESCB Annual Report 2016-17 (the full report is available on the <u>ESCB website</u>.)

Is Safeguarding a Significant Issue in Essex?

The vast majority of the 306,000 children in Essex led healthy, safe lives, in 2016-17, but a small minority faced challenges in their life and family circumstances which puts their wellbeing and safety at considerable risk. For example:

- 9,850 children were referred to Children's Services during the year because someone had a concern about a risk of abuse or neglect. Police (30%), schools (17%) and their own family members (7%) were most notable in making these contacts. 74% of those cases (over 7,200) were felt to need a Child and Family assessment by Children's Services.
- Investigations of child sexual exploitation continue to be needed. At the end of the year, current

investigations involved 107 Essex children with 38 of these being at a high risk of sexual abuse happening.

- Children are at risk of exploitation and harm when they go missing from home. Across the year 361 children were reported missing – 42% of them were 'looked after children'.
- National estimates show 1 in every 5 children is exposed to domestic violence by the age of 18. Within Essex, police officers recorded over 10,000 domestic abuse crimes in the year, many involved children as witnesses or in the household at the time of violence.
- Family issues significantly add to the levels of stress and anxiety for children, affecting their mental wellbeing. 25% of Essex households have children under 5 in

a household where family members have self-diagnosed with depression or stress.

Are safeguarding issues getting better or worse?

Child Protection Plan numbers have remained consistent month on month across all quadrants, though the number of children on a Child Protection Plan was fractionally lower at the end of 2016-17 than 2015-16 figures by 5% (approx. 50 cases).

The Board was notified of 65 deaths of children from a wide range of circumstances during the year. Although below the 2015-16 figure, this is broadly similar to the numbers over the past four years. The most significant 'modifiable factor' in reviewed cases was the sleeping arrangements when young children die unexpectedly. These deaths showed a slight rise in number.

Nationally, levels of stress and emotional ill-health amongst children is worsening. In Essex, hospital admissions for under 24's who have self-harmed continue to increase, although they are still below national averages. Young women are more affected by this than young men.

Numbers of sexual exploitation cases have risen significantly in Essex over the past five years – but this reflects the much greater awareness and reporting of cases rather than changes in offending and abuse. The vast majority of child sexual exploitation cases involve one offender and one victim, but cases of multiple offenders abusing a number of girls are happening.

Some exploitation is embroiled in drug trafficking and gang offending. Along with emotional ill health, the 'export' of gang related offending from cities into Essex is the biggest current threat to young people in Essex.

How has ESCB focussed its work in 2016-17?

In a few pages, it is not possible to set out the very wide range of activities the ESCB has led or contributed to, however the work has included:

Working with children and young people

The Board used the County Council's research to identify the three key areas that most worried young people and asked for their views and experiences to shape the work of the Board and its partners going forward. These three areas were:

Self-harm - over 200 young ٠ people shared their perceptions and experiences of self-harm and this was the focus of the Board Development Day in October 2016 which was led by young people. The findings of this work further informed the revision of an ESCB suicide prevention toolkit being used in schools and youth organisations. This work contributes to the suicide prevention strategy being implemented across Essex,

Southend and Thurrock. Children's Mental Health continues to be a ESCB priority for 2017-18.

- Child Sexual Exploitation (CSE) – a significant amount of understanding has been gained by surveying over 2,000 Year 6 and Year 8 Essex pupils about their understanding of CSE risks. This is being used to design and deliver improved services by partners.
- Challenges of Leaving Care young people leaving the care of the County Council put together a video about their experience and what needed to be improved. The challenges of housing, finance and support in making important decisions were particularly highlighted by the young people as they became independent. This, together with a survey of their experience, was used as the basis of two discussions at the ESCB Board, Individual partners are using the information to address the gaps in their particular services.

Child Deaths

Along with its neighbouring Boards, ESCB reviews the death of every child, whatever the circumstances. The overall number of deaths is low but in 2017-18 the reviews showed a slight rise in the number of Sudden Unexpected Deaths of Infants (SUDIs) where the child's sleeping arrangements could have been a factor. As a result, the Board reinvigorated its campaign about 'Safe Sleeping', highlighting the risks of children sleeping with an adult. This included a 'Thunderclap' social media campaign in January 2017 with its messages reaching over 450,000 people.

Reviewing Serious Cases of Neglect and Abuse

The Board carries out in-depth case reviews if a child has died or been seriously injured through neglect or abuse. During the year, it considered five cases where children had been seriously injured. None of these required a formal, legally required process of 'a Serious Case Review' but the involvement of agencies in each case is being looked at in depth to ensure that any lessons are learned.

One Serious Case Review from a previous year was completed and published in 2016 regarding a nonaccidental injury to a 14 week old baby. This review made a number of recommendations for improvements in practice, including:

- Promoting understanding of operational pathways between agencies
- Review of policy and procedures relating to parental mental health and the impact on parenting
- Inclusion of guidance around information sharing and recording in GP Contracts

These recommendations are now being implemented by all agencies.

The Board continued to work on a number of recommendations from previous years which had focussed on information sharing, pre-birth assessments, hospital discharge processes, complex parenting circumstances and risk management. The action plans for learning from these events were all completed in 2016 with new guidance and training being provided where needed.

Child Sexual Exploitation (CSE)

The Board's 'I Didn't Know' campaign raising awareness of CSE was revitalised. It particularly targets parents, carers and school staff on dealing with risks using a range of material such as this <u>parent/carer</u> <u>leaflet</u>.

Following the good examples set by Brentwood and Harlow Council, most of the City, District and Borough councils provide mandatory training for licensed premises and taxi drivers raising awareness of CSE. Where this isn't happening, councils provide information leaflets and cue cards to licensed taxi drivers as part of their induction and training.

How much did ESCB's work cost in 2016-17?

The Board's work is funded by partner contributions and a small training income. In 2016-17 contributions totalled £384,000. The work was achieved within that budget. The contributing agencies were:

(In addition, Thurrock and Southend Councils contribute £5,551 each towards the cost of the Child Death Review process which involves all three areas).

Partners also support the Board's work by providing accommodation and specialist staff for specific tasks. Over recent years, Safeguarding Boards' increasing demands have included Child Sexual Exploitation, gang involvement and bullying through social media. Contributing agencies have recognised these increasing demands, by maintaining a standstill budget for the Board, when many other public sector budgets have had to be cut.

What will ESCB be focussing on in 2017-18?

ESCB priorities are featured in its <u>Business Plan</u> which includes taking into account issues arising from operational practice, lessons from case reviews, national priorities and partners' view of risks to children. The Board is prioritising:

1. Focussing on areas and issues of greatest risk and concern to safeguarding of children

These include:

- Evaluating the impact of Domestic Abuse
- Raising the profile of Neglect
- Evaluating the approach to Preventing Radicalisation
- Evaluating partners approach to internet safety
- Evaluating partners approach to youth offending and gangs
- Leading Child Sexual Exploitation Initiatives
- 2. Assessing the effectiveness of early help and appropriate interventions when needs are identified.

This includes:

- 0-19 services: Evaluate the impact of the new 0-19 contract
- Thresholds: Assess the impact of threshold decisions on those children who are not stepped up to higher levels of intervention
- Children moving into Essex: Evaluate the safeguarding of children and instigate work with other Safeguarding Boards to

support agencies addressing these risks

3. Receiving assurance that children are kept safe through having access to appropriate services and support for their emotional health and well-being

This reflects the partners' awareness of the importance of effective mental health services in safeguarding children.

4. Strengthening partnership and leadership

This is a particular focus, as the Children and Social Work Act 2017 and related guidance is changing the safeguarding expectations on partners.



Essex Safeguarding Children Board Business Plan

2017 - 2019

Introduction

Our vision is that "children and young people in Essex are seen, heard and helped; they are effectively safeguarded, properly supported and their lives improved by everyone working together."

The Essex Safeguarding Children Board (ESCB) Business Plan sets out the strategic intent of the ESCB in making this vision a reality. It underlines the statutory objectives of the ESCB to coordinate and ensure the effectiveness of safeguarding arrangements with priorities set for 2017/18 being updated following discussions with its partners.

Our Principles

- Safeguarding is everyone's responsibility.
- At the core of our safeguarding and child protection work is the commitment to understand the quality of a child's experience of local services
- To learn from individual experiences and have a positive impact upon young lives
- To champion and protect the safeguarding needs of vulnerable children and young people
- Our work is characterised by an attitude of constructive professional challenge
- To foster a culture of continuous review and learning with evidence based practice
- To foster a single child-centred culture, focussed on the needs of children, young people and their families
- To capitalise on the unique opportunities presented of being the 2nd largest board in the country.

Our Priorities

The ESCB Business Plan 2017-2018 is intentionally brief and focused on strategic priorities that form the basis of the work of the Board over the year. These priorities support the statutory functions of the ESCB and the partnership response to protecting vulnerable children and young people, preventing harm and promoting their welfare. They are;

- Priority 1: The Local Safeguarding Context
- Priority 2: Early Help & Early Intervention
- Priority 3: Emotional Health & Well-being
- Priority 4: Strong Leadership & Strong Partnership

Annually, the ESCB will identify the specific actions required against each of these priorities with the detail being set out in the specific work plans of the Board's sub groups and working groups.
