#### Mid Essex Area Forum Scrutiny Task and Finish Group Re:

Thank you for your letter of 17 September 2010 regarding Phlebotomy and Audiology Services provided by Colchester Hospitals University NHS Foundation Trust to Mid Essex residents.

Strictly speaking, under the Patient Choice arrangements any patient can access services at any provider hospital, which means that subject to them exercising 'Choice', residents from the areas named in Braintree, Chelmsford and Maldon can access CHUFT services at any of our hospital sites. With that caveat I am setting out below the response to the specific questions you raised.

#### Phlebotomy

The Trust provides its GP-referred Phlebotomy services principally from sites at Colchester General Hospital and Essex County Hospital; these are available Monday to Friday and are located in the Outpatient departments at both sites. We also provide similar services at Clacton Hospital and Harwich Hospital.

Geographically in the Mid Essex PCT area, the phlebotomy services at Halstead Hospital are provided by Mid Essex PCT provider services, although the samples come to the Colchester laboratories for testing and reporting. Similarly samples taken by practice staff in GP surgeries in the Halstead and the Colne Valley practices are sent to Colchester for testing.

At the new Braintree Community Hospital, CHUFT provides the laboratory support from Colchester to the clinical services provided by Interhealth Canada, although the phlebotomy service itself is provided by Interhealth Canada's staff. I understand that GP referred phlebotomy provided at Braintree Hospital is managed through Mid Essex PCT provider services and these samples go to Broomfield for testing.

#### Audiology

The Trust provides its Audiology principally from Essex County Hospital; these are available Monday to Friday and are located in the Outpatient department. The service at ECH includes full diagnostic audiology testing facilities; it also provides support to patients with hearing aids requiring simple repairs and battery exchange. These support aspects of the service operate on a drop-in basis supported by a telephone helpline and supports all users with a postal repair service. We provide similar services at Clacton Hospital and Harwich Hospital.

At Halstead Hospital our Audiology team are in attendance to support the ENT clinics there and also provide a hearing aid repair service for a half day session on the 1<sup>st</sup>, 3<sup>rd</sup> and 5<sup>th</sup> weeks of a month. Local patients for hearing aid support are seen as far as possible in Halstead, with the exception of their first time fitting where this needs facilities not available in Halstead. In special circumstances it is possible for patients who are house bound to have a home visit assessment. There is also a Hearing therapy clinic in Halstead every fortnight.

I hope this addresses the issues you are investigating. If we can be of any further assistance please contact Nick Chatten, Director of Corporate Development who will be happy to help.

Thank you for your letter of 17 September 2010 to Carole Taylor-Brown requesting information for the above group. Please be advised that Carole Taylor-Brown stepped down as Chief Executive on 30 September and I took up post as Chief Executive of NHS Suffolk on 1 October.

Turning to the information requested, regardless of where a patient resides, all patients can access direct access (GP referred) phlebotomy and audiology at Ipswich Hospital and West Suffolk Hospital in Bury St Edmunds. In addition, many individual practices take bloods and send them to the hospital laboratories.

Unfortunately I am unable to confirm the frequency and drop in service details, however, the most up to date timetable of clinics and their frequency can be obtained from the Patient Advice and Liaison Service of the respective hospitals.
