

# Equality Impact Assessment

## Context

1. under s.149 of the Equality Act 2010, when making decisions, Essex County Council must have regard to the Public Sector Equality Duty, ie have due regard to:
  - eliminating unlawful discrimination, harassment and victimisation, and other conduct prohibited by the Act,

As of 2011 there was a population of 121,859, therefore deemed to be one of Britain's fastest growing towns. Individuals aged 16-64, equating to 64.2% of the town.</b></p>

If so, what were their views and how have their views influenced your decision?</p> <p><b>The views of local residents are represented on the LHP by four Colchester and seven County Councillors. The Councillors not only represent the views of local residents but also other bodies, such as Housing Associations.</b></p> <p><b>The speed limit would then be subject to a formal public consultation.</b></p>
