Executive summary

Title of policy / decision: Operational Property Estate Transformation - Resource Investment Decision

Policy / decision type: Cabinet Member Action (CMA)

Overview of policy / decision: The decision is to allocate the necessary resources (external consultancy support and additional in-house staff members) to undertake the work required to develop Strategic Asset Management Plans (SAMPs) for each of ECC's operational assets. This work will take place over the next 3+ years and will be delivered in two key stages. The first stage focusing on ECC's estate to understand where efficiencies can be delivered and a second stage broadening the review to the wider public estate. Stage 2 will involve working with other Essex LA's, NHS and Blue Light through the One Public Estate forum.

What outcome(s) are you hoping to achieve?: This work will establish a future strategy for each operational asset taking account of condition, cost, operational efficiency, service requirements, net zero and many other factors. Assets found to be surplus will be identified for disposal and will follow a defined disposal process to ensure Best Value. Other opportunities for colocation both between ECC services and with Partners will be investigated and implemented wherever possible. This will facilitate the delivery of a smaller, better and greener estate for ECC, saving money for taxpayers (annual revenue costs and capital maintenance costs + Capital receipt opportunities).

Deliverables will be measured in a number of different ways including reductions in annual running costs of the estate and improvements in customer and staff satisfaction with facilities.
