Welcome and Introduction

Cllr Mike Steel, the acting Chairman of the Place Services and Economic Growth Policy and Scrutiny Committee, welcomed those in attendance.

1. Membership, Apologies, Substitutions and Declarations of Interest

The report on Membership, Apologies and Declarations was received, and it was noted that:

- 1. The membership of the Place Services and Economic Growth Policy and Scrutiny Committee was as shown in the report.
- Apologies had been received from Cllr D Blackwell, Cllr P Gadd, Cllr A Goggin and Cllr H Whitbread. Cllr S Barker was substituting for Cllr A Goggin and Cllr M Steel was chairing the meeting in his absence.

2. Minutes and Matters Arising

The Minutes of the meeting held on Thursday 23 March 2023 were approved as a correct record and were signed by the Chairman.

The Matters Arising report and the following points were noted:

• An update had been requested on the proposed LHP 'tracking tool' and planned LHP member training.

3. Questions from the Public

There were no questions from the public.

4. Work Programme

The updated Work Programme was noted.

5. Arts, Culture and Creative Sector including the new Cultural Strategy

Cllr Graham Butland introduced the report (PSEG/09/23) and a presentation which can be found <u>here</u>.

Members were invited to ask questions and provide comment. Key points raised during this discussion included:

- The Council was looking to work with education establishments to promote BFI (British Film Institute) courses.
- KPIs for the Cultural Strategy would be developed with current targets focused on participation numbers and attracting match-funding.
- A 'mapping process' of cultural hubs and venues was planned.
- In response to concerns about the spatial pattern of the projects awarded funding under the Arts and Culture Fund (Year 2), it was confirmed that work was underway to address this and support those organisations that had not received funding (including smaller organisations).
- The criteria for awarding funding were outlined including how the bids supported the Everyone's Essex strategy and the 'Levelling-up' agenda.
- It was reported that the quality of applications to the Fund was extremely high, and this meant only 10% of applicants had received funding. Feedback had been given to those organisations that were not successful.
- It was agreed that officers would report on progress to support arts and culture outside of established clusters (e.g., around cities) including in more rural and disadvantaged communities.

- The work of the Film Office was outlined, and it was noted that there were huge opportunities in the sector including an ambition for a Film Studio in Essex.
- A budget of £1.5m had been in place since 2021 to support the arts and culture in Essex over the next 5 years. This was being delivered through the Arts and Cultural Fund, a newly formed Cultural Development Team and the Essex Film Office.
- It was agreed that going forward County Councillors would be asked to help promote and distribute information on the Arts and Cultural Fund.
- It was noted that location filming could bring significant benefits and the Council had worked closely with various production companies including TOWIE (The Only Way is Essex).

EXECUTIVE SUMMARY

- Phase 1 short term strategy up to 2025 to help plan for rapidly evolving EV landscape
- Bottom-line is 'Right Charger, Right place' focusing on 6 objectives:
 - Residents, businesses, and visitors will be able to use electric vehicles and be assured there is an accessible, reliable, easy-to-use, safe, and fairly-priced charging network
 - Supporting communities with the socio-economic inequalities of using and charging an EV
 - Tackling the environmental priorities of reducing car travel and decarbonising vehicle emissions across the county
- Strategy won't install multitude of charging points by itself
- Subsequent strategy phases will focuses on other vehicles (buses etc) and fuels (hydrogen)
- Electrifying the ECC employee and commercial fleet are separate projects

UNDERLYING PRINCIPLES

- EVs are **part of the solution** for transport decarbonization and **must not** be seen as the panacea can't make it too easy for people to use EVs for trips that can be made more sustainably
- ECCs role is to **enable** a transition to EVs, **leading by example**, applying best practice and ensure there are no gaps in the charging network
- The private sector will play a pivotal role in infrastructure roll out but likely to focus on profitable sites only
- Only 300+ public EV charge points (EVCPs) in Essex behind national average
- Thirty-fifty percent of Essex households do not have off-street parking and no current (legal) means of charging their car using their electricity supply
- In 2021 Essex had 18.5k registered zero emission Battery Electric Vehicles (BEVs) estimated by 2025 there could be 30k-55k and 120k-220k by 2030.
- Greatest demand is likely to be in Basildon, Chelmsford, Colchester & Epping Forest

FUNDING SITUATION AND FINANCIAL IMPLICATIONS

Strategy is a framework to access funding - currently 3 different funding avenues:

1. Internal ECC

- EV strategy and fleet allocated £400,000 from the climate reserve £100K spent so far developing the strategy, writing the ORCS bid and, on the MITIE, (property) project
- Further expenditure is expected on the strategy consultation, action plan implementation, telematics within the commercial fleet and installation of charging points at ECC offices. Full cost implications will become clearer as work is developed.
- 2. External Central Government e.g., Office of Zero Emission Vehicles, ORCs, LEVI
 - There is no limit on how many ORCS bids ECC can submit
 - March 2023: Successful ORCS bid of £236,210 covering 60% of the costs to install 66 EVCPs in 30 locations across Essex. The remaining 40% and any additional costs will be paid for by a Charge Point Operator (8–12-year contract).
 - LEVI capability fund: Secured a further £129,600 for resource funding (2023/24)
 - LEVI capital fund: Indicative allocation of £8,382m (capital) and £590,400 (revenue) (2024/25)

1. Introduction

1.1 This report summarises the review carried out by the Place Services and Economic Growth Policy and Scrutiny Committee (PSEG) into the Member-led Pothole Scheme on 20 April 2023.

2. Recommendations

The Committee is asked to

- note that the Conclusions and Recommendations (Paragraph 4) have been referred to the Cabinet Member for Highways Maintenance and Sustainable Transport.
- consider the response of the Cabinet Member (Appendix 1).

3. Background

- 3.1 Following the PSEG meeting of 16 March 2023, the Chairman (Cllr A Goggin) agreed that an all-committee Task and Finish Group should be established to conduct a one-off review of the existing member-led pothole scheme and make any necessary recommendations to the Cabinet Member for Highways Maintenance and Sustainable Transport.
- 3.2 The Committee met on 20 April 2023 to conduct this review immediately following the conclusion of the formal public meeting of PSEG.
- 3.3 The Committee considered the results of the all-member survey on the scheme. This had been sent electronically to all ECC members and saw a response rate of just over 50% (39 members).
- 3.4 It was agreed that following the 20 April meeting, the Vice-Chairman (Cllr M Steel) would work with officers to summarise the discussion. This summary is outlined below ('Conclusions and Recommendations').
- 3.5 It was further agreed that this summary would be given to the Cabinet Member Page 24 of 47

for Highways Maintenance and Sustainable Transport ahead of the 18 May PSEG meeting for his response. His response is attached as Appendix 1.

4. Conclusions and Recommendations from the Task and Finish Group


- 4.1 Conclusions and Recommendations from the Member-led Pothole Scheme Survey (see Paragraph 5 for a full summary):
 - A majority of members would like to see the member-led pothole scheme continue and be extended (e.g., to include footways).
 - Members would like to see a tracking system and a streamlined reporting system. Ideas in this area included a 'live' tracking system allowing members to see the status of each submitted pothole and incorporating the member-led scheme into the existing reporting system on the 'Tell Us' website to avoid duplication.
- 4.2 Recommendations from the PSEG Task and Finish Group discussion on 20 April:
 - Reflecting the results of the survey, PSEG members would like greater clarity on whether the existing scheme provides value for money.

This should include information on the cost per pothole of the memberled scheme compared to a pothole repaired through the 'normal' Highways route.

- Members should be provided with an annual scheme of work showing the planned scheduling of local repairs (including through s106 contributions) in their division. This could then be used by councillors to inform their choices for the member-led scheme.
- The timings for the scheme should be reviewed with some members suggesting that the deadline for submissions under the current scheme was too early, as many potholes only appeared after winter.
- Members would like to see greater clarity provided on the resource available and planned timetable for work to ensure that expectations match reality. This reflected members' disappointment that some repairs submitted under the existing scheme remain outstanding.

5. Evidence – Member-led Pothole Scheme Survey Responses

5.1 All Members were asked to complete a survey regarding the Member-led Pothole Scheme. 39 Members completed the survey, producing in the following results.



5.1.1 What is your overall experience of the member-led pothole scheme?









1. Introduction

- 1.1 This report is in response to the review carried out by the Place Services and Economic Growth Policy and Scrutiny Committee (PSEG) into the Member-led Pothole Scheme on 20 April 2023.
- 1.2 A number of recommendations, outlined below, were out forward following this review. Responses to these recommendations are laid out below each point.
- 1.3 The Cabinet Member for Highways Maintenance and Sustainable Transport is attending the PSEG Scrutiny Committee on the 18 May 2023 where he will welcome further discussion.

2. Recommendations and Responses

2.1 **Recommendation:** A majority of members would like to see the member-led pothole scheme continue and be extended (e.g., to include footways).

Response: adding footways or other such extensions would add complexity to the jobs that are being delivered, which would result in further delays to timescales; delays in the jobs being completed was a specific point raised at previous PSEG Scrutiny meetings, and one that we are keen to avoid. The 2023/24 Member led pothole scheme will be pothole specific again; however, there are schemes that are going through the Local Highway Panels that focus on footway repairs.

2.2 **Recommendation:** Members would like to see a tracking system and a streamlined reporting system. Ideas in this area included a 'live' tracking system allowing members to see the status of each submitted pothole and incorporating the member-led scheme into the existing reporting system on the 'Tell Us' website to avoid duplication.

Response: The existing tracking and reporting system set up was to ensure submissions relating to the member-led pothole scheme could be managed as a standalone work stream within the organisation. This is the most efficient method of operation for the service and ensures budget is not spent on additional staff resources or new/alterations to IT systems.

The current system generates emails to the Member who submitted the report

at the following stages:

- When received into system
- If Rejected
- Planning the works
- When completed

This is in line with the 'Tell Us' reporting/submission system.

To provide any more information than this would require additional staff resources to be employed and charged to the ring-fenced budget available, therefore reducing the amount available for works on the Network.

2.3 **Recommendation:** Reflecting the results of the survey, PSEG members would like greater clarity on whether the existing scheme provides value for money. This should include information on the cost per pothole of the member-led scheme compared to a pothole repaired through the 'normal' Highways route.

Response: There is no difference in cost for 'normal' or Member led potholes repairs. The Member led scheme was programmed to ensure delivery teams went into specific areas with the plan being to complete everything available from Member submissions on these visits.

Costs per pothole is not an available option as the operational delivery is at a Task Order level and includes all staff, direct resource and Supply Chain Partner resource. Each pothole varies in size and so comparison is not always beneficial or a true reflection. A single submission may cover more than one pothole and could also rectify a number of defects.

2.4 **Recommendation**: Members should be provided with an annual scheme of work showing the planned scheduling of local repairs (including through s106 contributions) in their division. This could then be used by councillors to inform their choices for the member-led scheme.

Response: This is something that is being looked at across the Service and being managed by the Communications Team. Further information on any progress will be shared in due course. We have already rolled out a monthly update to all County Members that will show the planned works in their district for the month ahead. We would welcome all Members to share this information with the residents they represent.


2.5 **Recommendation:** The timings for the scheme should be reviewed with some members suggesting that the deadline for submissions under the current scheme was too early, as many potholes only appeared after winter.

Response: The submission programme was shared in advance and was prepared to try and ensure there was a consistent and regular submission of potholes throughout the period of the scheme. This was to ensure that all resources, staff and operational delivery, were utilised efficiently over the course of the year. The graph below shows actual against programmed submissions.

It is important to stress that delays to submissions greatly impacts when the work can be completed, as the graph shows. The Cabinet Member extended submissions in 2022 to allow for some entries to be submitted as late as January, meaning that these are still being delivered now.

We are planning on starting the scheme as early as possible this year and so this will allow for potholes that have appeared during the winter season the be submitted when the first round opens for each Member.

There will not be an opportunity for extensions this year for submissions, and the Cabinet Member asks that Members support him in this and ensure that potholes are submitted on time to allow for the works to be completed according to the programme. This ensures the schemes operates in the most effective and efficient way possible.



2.6 **Recommendation:** Members would like to see greater clarity provided on the resource available and planned timetable for work to ensure that expectations match reality. This reflected members' disappointment that some repairs submitted under the existing scheme remain outstanding.

Response: Until specific locations of submissions are inspected it is difficult to give a timeline in advance. Each location is impacted by traffic volumes, road layout and position of pothole in the carriageway. If a road closure is required for example, this can take up to 13 weeks before approval is granted.

Individual reports would not be possible without additional staff resource being allocated. If there are any efficiencies or ideas on automation that can be identified during the above exercise on 'reports for future planned works', this could be considered.

We would again stress the importance of the submissions being made on time, as delays in submission mean delays in the work being programmed and carried out.

3. Update and Next Steps

3.1 There will be a Member-led pothole scheme for 2023/2024. The scheme will function in much the same way as 2022/2023 scheme. We will be communicating with all Members when final details become available.

It should be noted that this quarter's figures show a large difference in the number of defects across the network since previous reports.

Please be aware that on top of defects repaired through programmed works etc, an ongoing project to cleanse Confirm (the system we use to record defects) of redundant and superseded data has occurred, which is responsible for the majority of the Defects figures. The data in question has been archived in Confirm and consists of:


- Historical defects from the old contract that have since been superseded around 2019.
- Enquiries that are plotted within close proximity of existing defects and have been linked up to avoid duplicating inspections.
- Enquiries relating to old initiatives such as Member Led Pothole Project 2020 and Ride London 2022.
- Old jobs that have been raised prior to 2021 and not undertaken (defects have been detached from these).

The total number of defects archived through the above project was 52,747.

This mean that the data we hold is now more reflective of the actual number of defects across the County.


