2.1	Is this a new policy (or decision) or a change to an existing policy, practice or project? New project	
2.2	Describe the main aims, objectives and purpose of the policy (or decision):	
	This proposal is driven by the County Council's Organisation Strategy to deliver the best possible educational outcomes for children attending schools within its administrative border, in this particular case those at West Horndon Primary School, Brentwood.	
	What outcome(s) are you hoping to achieve (ie decommissioning or commissioning a service)? Brentwood has experienced a rise in the demand for primary school places in the last few years as a result of rising birth rate. Latest forecasts indicate continued growth in pupil numbers in the town and additional provision is required to balance future supply and demand for local primary school places.	
	Essex County Council must meet its statutory duty to ensure that each child within its administrative border has a school place available to them. As part of a package of measures coming forward to meet the forecast demand, the governing body of West Horndon Primary School agreed to a consultion with the community on the expansion of the school to accommodate an additional 105 pupils, increasing its overall capacity to 210 pupils.	
2.3	Does or will the policy or decision affect:	
	Being an expansion there will be no adverse impact upon any of those groups mentioned above. However, should additional places not be delivered for	

September 2019 there is a significant risk that children will be without school places in their local area, that longer journeys will need to be made between home and school in order to find alternative schools with spaces and that in an increased number of cases parental preference will not be satisfied. The building works will be procured by the County Council using framework agreements which it is entitled to use. Contractors experienced in working on projects of this type will be used. The premises to be provided will need to meet the statutory requirements of the Education (School Premises) Regulations 1999 and the feasibility studies and the final programme will ensure that this happens. As public buildings, schools are required to provide full accessibility in order to obtain Building Control sign-off. Essex County Council produces a set of employer's requirements which add further interpretation to ensure this is achieved from the early stages of design. Prior to planning permission application Building Control approval is sought to offer earlier compliance confirmation. Any works to expand the building will be fully compliant with the legislation. This builds in a futureproofing dimension to our buildings, ensuring they are accessible for disabled users. Will the policy or decision influence how organisations operate? Rather, there is appropriate capital investement to accommodate additional pupils and, school funding being largely pupil-led, these pupils generate additional resources for the school. 2.5 Is this policy or decision associated with any of the Council's other policies and how, if applicable, does the proposed policy support corporate outcomes? 3.1 What does the information tell you about those groups identified?

The percentage of pupils at West Horndon Primary School in January 2018 who were identified as White British was 86.8%, compared with a figure of 75.9% accross the district of Brentwood as a whole in the same age range. The expansion will increase the number of pupils to be admitted each year. It will not change the arrangements for admission to Reception year (beyond making more places available and thereby better satisfying parental preference, as previously stated). A higher number of children from the same community will therefore have the opportunity to access education at West Horndon Primary School. There is no reason to suggest that the proposed expansion of the school will affect the population mix directly.

Have you consulted or involved those groups that are likely to be affected by the policy or decision you want to implement? If so, what were their views and how have their views influenced your decision?

A public consultation on the proposed expansion was undertaken between 17 September 2018 and 14 October 2018. A large number of individuals and groups were consulted, which included all local members on Essex County Council, Brentwood District Council, all schools within Brentwood District, Trade Unions, as well as parents/ carers, staff and pupils at the school concerned. Public meetings – the times and date for which being advertised in a number of ways, including the local press - were held at the school. Significant engagement with all interested parties was encouraged. Feedback from the meetings were supportive of the proposed expansion.

Statutory Notices were published in relation to the proposed expansion, between 21 November 2018 and 19 December 2018. No responses were received during this period.

Further consultation will be held with the community as part of the planning process, regarding the detailed design of the proposed building works, parking and traffic issues. The school will be engaged as a key stakeholder as part of the design process.
