4. A Board Policy on the Publicly Maintainable Highway (Minute 37/ July 2011)

The purpose of today's meeting is for the Committee to consider the evidence it has accumulated as a part of this scrutiny review, and to reach some conclusions for inclusion in a Scrutiny Report on the management of A Boards on the publicly maintainable highway in Essex.

6. Scrutiny Review on the Off Site Emergency Planning Requirements around COMAH Sites in Essex (Minute 10/ February and 26/ May 2011)

At its next meeting on 14 October 2011 the Committee will be undertaking a visit to the Port of London Authority in Gravesend.

Based upon the evidence that has been captured so far on this scrutiny review about the off site emergency planning requirements around COMAH sites in Essex, it appears that there may be merit in investigating the information that is provided by the County Council to the public on the Emergency Planning Service and, inter alia, COMAH sites. Consequently it is proposed that at its meeting on 18 November the Committee will focus upon the provision of information associated with the subject of the review. As part of the preparation for that meeting it is intended that Committee Members will undertake some individual research to identify what information is available on the work of the Emergency Planning Services and COMAH sites elsewhere in the country, and compare it with information available in Essex.
