The purpose of this report is to consider the Committee's latest work programme as set out at Appendix A, together with the following updates:

• Scrutiny Report on the exercise of planning control on the use of inert waste for recreational development

The Task and Finish Group that was set up to undertake this scrutiny review has produced a report for the Committee's consideration at its next meeting on 12 May.

• Essex Legacy from 2012 Olympic Games and Paralympic Games

At its first meeting on 24 February the Task and Finish Group gave some initial consideration to the response it has received from the Cabinet Member for Education and the 2012 Games to the lines of questioning that were identified in the original Scrutiny Report to monitor the pursuit of a legacy from 2012 Games. As part of its consideration the Group has accepted an invitation from the Cabinet Member to visit the Hadleigh Olympic Mountain Bike Venue, and the Basildon Sporting Village, which will be an opportunity to investigate how those venues will contribute to an Essex Legacy from the Games.

It is intended that the visit will take place in May after the Basildon Sporting Village has opened, and an invitation will be extended to all Committee members to take part.

• Corporate Carbon Reduction

The first meeting of this Group is scheduled to take place prior to this Committee meeting.

• Renewable Energy

The Committee has already accumulated some evidence on the generation of renewable energy, which is set out in a series of evidence sheets for instance on shore and offshore wind power, and nuclear power. Based upon this early work, the Committee agreed that the original scoping document should be revised in the light of experience with a view to clarifying how the review could be taken forward with clearer objectives (Minute 18/ April 2010). However, the development of the revised scoping document has been delayed due to other intervening priorities identified for consideration by the Committee. It is notable that one of the priorities that the Committee has decided to take forward in the meantime is the Corporate Carbon Reduction scrutiny review.

At full Council in October 2010 (Minute 69) it was resolved that:

'Council notes the announcement in July by the Secretary of State for Energy and Climate Change that he is overturning the ban on councils selling renewable energy which will allow councils to sell energy to the National Grid. This creates the potential for councils across the country to produce their own renewable energy, e.g. wind turbines, solar panels on council buildings, bio-mass, to cut their power bills, reduce carbon emissions and raise much needed revenue at a time when they face significant financial pressures.

Council further notes that the Economic Development and Environment Policy Scrutiny Committee is undertaking a review of the effectiveness of the County Council's current carbon reduction and energy efficiency agenda. This review is in the context of the potential financial penalties that may be incurred if it fails to reach carbon reduction targets.

Council believes, as a community leader, it has a responsibility to take a lead on developing and implementing policies for reducing energy consumption, costs, carbon and other emissions.

Council therefore resolves to: continue to review the opportunities for generating green energy including solid recovered fuel as part of the Task and Finish Group established by the Economic Development and Environment Policy and Scrutiny Committee. To report back to Cabinet following that review having evaluated what green energy options could be actively pursued based on a sound financial business case.'

In view of the work already identified to be taken forward in the Forward Look and discussion between the Chairman and Vice Chairmen, it was felt that the Task and Finish Group would take forward the review proposed by full Council once it has concluded its work on the Corporate Carbon scrutiny review.

• Statutory Undertakers

A draft scrutiny report setting out the evidence collected by the Committee so far will be circulated to Members' in due course.

Park and Ride Schemes

A scoping document for this review was submitted to the Committee's last meeting, and it was agreed that the following two issues be added to the issues to be addressed in that review:

- To consider the availability of car parking in Chelmsford.
- To consider what work has been undertaken with retail businesses in Chelmsford in terms of identifying if there are any marketing incentives to promote the Park and Ride Scheme.

Members are encouraged to identify beforehand any specific questions that they may wish to raise at the Committee's next meeting in May when this review will be launched.

• Civil Parking Enforcement

At the Committee's last meeting this topic was identified as a potential scrutiny review. It is proposed that following on from its next scheduled meeting on 12 May, arrangements will be made for the Committee to consider informally how to take forward some projects over the coming months, including Civil Parking Enforcement. It should be noted that the Executive Scrutiny Committee has already undertaken some consideration on this topic as part of its review of the overall Transformation Programme and Shared Services.

• Credit Unions, and Debt Advice and Citizens Advice Bureau

These issues have been identified by Councillor Kendall. However, they are issues that fall within the remit of the Safer and Stronger Communities Policy and Scrutiny Committee and will be referred to that Committee accordingly.

Other matters

Other matters that will be investigated in due course for inclusion in the Forward Look include:

- Changes in the Civic Amenity Service
- Community Infrastructure Levy
