# COUNCIL AND BUDGET PRIORITIES TASK GROUP

#### Purpose of the group

- In the lead up to the publication of the 2010-11 draft budget, to advise the cabinet on council and budget priorities including
  - o Building our future (BoF) programme efficiencies
  - o unavoidable commitments
  - service pressures
- > To help the cabinet develop sound council and budget priorities for 2010-11 based on a realistic assessment of financial pressures and the results of the budget consultation process.
- > To respond to the cabinet once the 2010-11 draft budget is published
- To advise the cabinet on council and budget priorities for future years

### Timeline - October 2009 to January 2010

Meeting 1 – 6 October

Confirm the scope of the review (Simon Harper), Gloucestershire context (John Forster), council priorities (Rob Ayliffe), financial position (Mark Spilsbury) and BoF programme (Alan Richell)

Meeting 2 – After 19 October but before the end of October (day session) Service presentations from group directors/directors – to include service performance, financial position and BoF efficiencies.

Meeting 3 - by mid November

On the basis of the information gathered, to identify the headline issues to be included in a report to the cabinet.

Report initial findings to cabinet members (by the end of November)

Formal report to the Scrutiny Management Committee on 9 December and subsequently to the cabinet on 16 December.

Meeting 4 - By mid January

To consider a response to the cabinet on its draft budget proposals

Report to the Scrutiny Management Committee on 26 January and subsequently to the cabinet on 10 February.

#### **Budget Scrutiny: Buckinghamshire County Council**

#### Context

Buckinghamshire County Council is a conservative council with a large majority. It is rated as excellent by CPA and is a floor authority, with one of the lowest formula increases of any County Council. As with many councils, finances are restricted and set to worsen significantly in the medium term

#### **Budget Scrutiny- A Brief History**

The scrutiny of the budget at Buckinghamshire County Council was historically undertaken as a majority group challenge which was neither politically balanced nor in the public domain. For the 2006/07 budget round, a time limited Task & Finish Group was established at the last minute to review the findings of the majority group challenge. This achieved little real change and excited minimum interest in the general public or press.

For the past two years the majority group have continued to hold a challenge panel behind closed doors. However, in addition to this, scrutiny has played a more explicit part in the challenge process.

For the 2008/09 and the 2009/10 budget rounds, scrutiny committee members began building their understanding about the budget in the December meeting, including a discussion with the senior finance officer (The detailed programme is shown below). Two days were dedicated to the examination of the budget in public when individual Cabinet Members were invited to the committee to answer questions in three broad areas

- Performance against targets and budget in the current year.
- Anticipated impact of service reductions and investment proposals in both revenue and capital budget
- Risk

The committee then spent time drawing their conclusions together before the report was written and circulated to committee members and cabinet members.

#### 2009/10 Budget Timeline

The following table outlines the process that was undertaken for the last round of budget scrutiny, it is envisaged that the rough timetable will hold true for scrutiny of the 2010/11 budget.
