Overview of policy / decision: The Essex Local Delivery Pilot (LDP) is a way to secure funding to encourage the people of Essex to become more physically active. The proposals are about system change and new ways of working to encourage the 391,600 people in Essex who are inactive to enjoy the physical, social, and mental health benefits of an active lifestyle. The decision is to accept the conversation of the final £1,580,000 in-principal funding to hard commitment.

Rationale for assessment, including data used to assess the impact: The LDP prioritises groups experiencing inequalities in physical activity (including many of the above), projects that have effective targeted these groups include Prevention Enablement Model (people with disabilities); Movement for health at Outhouse East (LGBTQ+ community); Street Tag in Care Homes (Older People); Colchester Islamic Cultural Association (Religion/Belief).

31 projects funded by the Essex LDP were assessed as likely to increase capability. These included projects looking to deliver training or upskilling, such as upskilling and supporting older people to access digital physical activity opportunities, as well as projects enabling those 21 with additional barriers to take part in physical activity, such as disability cycling schemes and 'Pool Pod' which enables disabled people to easily access swimming pools.

Rationale for assessment, including data used to assess the impact: The LDP invested in a Holiday Hunger project which has now become the Holiday Activity Fund (HAF) programme providing opportunity for children on free meals to attend activity session with a free meal during the school holidays (supporting children and working families). The LDP programme provides residents in deprived areas of Tendring (including Jaywick and Clacton, Harwich), Colchester, Basildon the opportunity to participate in LDP funded activities to increase physical activity levels (including Pedal Power, Street Tag, Beat The Street, Prevention Enablement Model, Park Play etc)

What actions have already been taken to mitigate any negative impacts?: Active Essex have developed a Diversity and Inclusion Action Plan (DIAP) which builds upon our work as early adopters of the Race Equality Code and as Disability Confident committed employers. Rationale for assessment, including data used to assess the impact: The LDP has funded the Sport and Youth Crime Prevention project which uses Sport and mentoring to improve the outcomes of young people involved in the criminal justice system or at risk of offending/re-offending. One of the six intended outcomes of Essex pedal power is to increase the employability of local people by increasing access to employment education and training opportunities. Essex Pedal Power in Basildon has been particularly successful at reaching ethnic minorities by offering free bikes to low paid staff members at Basildon University Hospital.

What actions have already been taken to mitigate any negative impacts?: Active Essex have developed a Diversity and Inclusion Action Plan (DIAP) which builds upon our work as early adopters of the Race Equality Code and as Disability Confident committed employers. Rationale for assessment, including data used to assess the impact: Data from project participants shows that the Essex LDP has effectively reached people living in areas of deprivation with 78% of participants who provided postcodes living in IMD 1-4 and over half (54%) living in IMD 1-2. One of the LDP target areas is Tendring which includes the coastal areas of Clacton, Jaywick, Walton-on-the-Naze and Harwich and Dovercourt.

What actions have already been taken to mitigate any negative impacts?: The LDP takes an Asset Based Community Development approach which works with communities to create solutions that are appropriate to their context rather than 'doing to' communities.
