Executive summary

Title of policy or decision: Harlow Investment Fund

Describe the main aims, objectives and purpose of the policy (or decision): The decision is to approve ECC's investment in the Harlow Investment Fund Limited Partnership and each associated company through the subscription or purchase of no more than 10% of the shares of the relevant company. The investment Fund rewill address extant market failure, investing public sector capital to create a portfolio of investments focused on marginal viability sites, where they are too complex or where the return profile is too limited for the private sector, but development of which will create the conditions catalysing private investment and regeneration as well as deliver a financial return.

Use this section to record how you have assessed any potential impact on the communities likely to be affected by the policy (or decision): The Localities Function in partnership with Data and Analytics has carried out extensive analysis to understand the characteristics of the people and place in Harlow with this work determining the interventions that we make in the place. The analysis has used nationally available data sets (e.g. ONS data) as well as internal service data (anonymised) to enable us to built a picture about the challenges and opportunities that exist in the locality.

Through this work we have identified specific issues around the inclusivity of the economy, resident skills and quality of residential accommodation, all of which are factors constraining growth and development of Harlow. Specifically relevant to this decision, this analysis has identified that residents who live and work in Harlow earn £338 less each month than those commuting in, only 28% of residents work in skilled of professional roles and one in ten 16-64 year olds have no formal qualifications. Complex land ownership and below average land-values in the town centre have also been identified as barriers to delivering effective regeneration.

This work will positively impact upon the Harlow community, providing new high-quality and affordable accommodation in the heart of the town centre, providing access to housing that residents are not able to access. The regeneration will also directly deliver new employment space and skills infrastructure positively impacting upon the employment and learning prospects and opportunities for the community. The work resulting from this decision will catalyse economic growth and regeneration of Harlow District with evidence that a high-quality town centre is critical to enabling this growth and development, particularly Gilston Garden Town and the PHE

relocation which is expected to provide up to 2,500 jobs for Harlow residents.

There is no evidence to suggest that this decision will have impacts positive or negative on groups with protected characteristics. The analysis we have conducted shows that the above mentioned challenges do not have a disproportionately higher impact on any of these groups and the interventions that we are making through this decision will be accessible to all aspects of the population of Harlow and Essex residents regardless of any protected characteristic.
