## Active Travel Essex - Sawyers Hall Lane, Brentwood

The Essex County Council (Brentwood Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.19) Order 20\*\*

**Notice hereby given** that the Essex County Council proposes to make the above Order under Sections 1(1), 2(1) to (3), 4(1), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

**Effect of the order:** To revoke the existing 'Limited Waiting Mon-Sat 9:30am-4:30pm 2 Hours No Return Within 4 Hours' parking bays to be replaced with 'No Waiting at Any Time' restrictions on the following lengths of road in the Borough of Brentwood:

Road	Description
Sawyers Hall Lane, Brentwood (West Side)	<ul> <li>i. From a point approximately 63 metres northwest from the northern kerb line of the Becket Keys School access road, northwest for approximately 4 metres.</li> <li>ii. From a point approximately 14 metres northwest from the northern kerb line of the Becket Keys School access road, northwest for approximately 25 metres.</li> <li>iii. From a point approximately 15 metres northwest from the northern kerb line of the Grove House School access road, northwest for approximately 52 metres.</li> <li>iv. From a point approximately 14.5 metres northwest from the northern kerb line of the Ravenscourt apartments access road, northwest for approximately 27 metres.</li> </ul>

This Order will be incorporated into The Essex County Council (Brentwood Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by substituting tile numbers TQ595 942 Revision 0 to 1, TQ595 945 Revision 1 to 2, TQ590 945 Revision 1 to 2.
