Davies Commission – Independent Airports Commission

- In 2012 the government asked Sir Howard Davies to chair an independent Commission tasked with identifying and recommending options for maintaining the UK's status as an international hub for aviation.
- The Commission will publish by the summer of 2015 a final report, for consideration by the government and opposition parties, setting out recommendations on how to meet any need for additional airport capacity in the longer-term.
- The need for ECC to come to a view on the work of the Davies Commission, and to instruct the various responses ECC has offered to its calls for evidence, inspired the council to publish its 'Flights of Fancy' document in 2013.

ECC's Long Term Strategic Aviation View

- Heathrow Complete closure is not realistic or desirable, a third runway at Heathrow is the most viable option.
- Super Hub at Stansted/Thames Estuary ECC does not support a new super hub at Stansted/Thames Estuary. If Heathrow remains open a rival 'super hub' is unviable and unsustainable.
- Stansted ECC supports sensible growth at Stansted including maximising the use of the existing runway. ECC recognise and will support MAG in introducing new destinations and long haul flights.



Key Principles for Aviation

ECC supports MAG in making best use of existing capacity, specifically –

- The reform of Air Passenger Duty to incentivise the take up of spare capacity;
- Improve surface access to airports with unused capacity, especially rail connectivity;
- Explore other reforms to make best use of existing capacity;
- Promote competition between airports by removing economic regulation and championing consumer interests; and
- Liberalising the UK's bilaterals policy to open up capacity.



Airport Surface Access Study

To inform ECC's positioning in response to the Davies Commission final report, ECC has commissioned Jacobs to undertake a study, to:

- Identify the potential surface access investment requirements needed to facilitate growth at Stansted and Southend Airport.
- Highlight the extent and characteristics of the forecast capacity issues associated with passenger growth on key corridors within the vicinity of the airports.

A second study may then be required to identify a preferred package of transport measures required to accommodate future growth, supported by a rationale for investment.

This work will then be used to inform ECC and partner lobbying and investment strategies to secure and direct funding in support of surface access capacity improvements.
