o Lot 2 Creative or physical therapies
o Lot3 Psychotherapy or talking therapy
o Lot4 Family therapy
o Lot 5 Therapeutic short breaks or activities for the child
o Lot 6 Therapeutic life story work for the child
o Lot 7 Specialist Assessments

ECC and SCC require these services to fulfil their duties to provide post adoption and SGO support as specified in the Children and Families Act 2014 and the Special Guardianship Regulations 2005. ECC and SCC Adoption and SGO front line staff have been part of the commissioning project group to determine the support required. Both staff and parental views have been incorporated into this re commissioning ensuring that the Lots available reflect all the services that have been accessed over the last 4 years. To ensure the adoption and SGO support services provided continue to meet family's needs, the Lots have been extended to include all the support services listed within the Adoption Support Fund (a funding stream for (LAS)

and regional adoption agencies (RAAs) to pay for essential therapeutic services for eligible adoptive and special guardianship order (SGO) families), increasing the variety and availability of support services for the teams to meet family's needs. Some of these services will be new services for families and some were provided through waivers and RFQ's as they were not on the original framework to access.

By re commissioning this service the adoption and SGO support services can continue to provide the support services required by families.
