2.2	<ul> <li>Describe the main aims, objectives and purpose of the policy (or decision):</li> <li>Approve an amendment to the current Part Night Lighting (PNL) scheme to allow Basildon Borough Council to fund the restoration of street lighting during the hours of 1am and 5am six days a week and between 12am and 5am on a Sunday night/Monday morning from 31 October 2019 to 31 March 2024.</li> <li>ECC has always recognised that District/Borough Councils are best placed to assess whether there is strong public support for all night lighting in their area and may, on amenity grounds, wish to reflect local wishes for this amenity – that way local people can assess whether the additional expenditure is justified given the competing demands for scarce public resources</li> <li>What outcome(s) are you hoping to achieve (i.e. decommissioning or commissioning a service)?</li> <li>The decision will allow ECC to into a new agreement with Basildon Borough Council to suspend the part night lighting policy for the period 31 October 2019 to 31 March 2020. A further 4 year agreement will then be signed for the period 1 April 2020 to 31 March 2024.</li> <li>Basildon have made this request on the grounds of amenity and to reflect public support for all night lighting in this area.</li> </ul>
