1 Election of Chairman

7 Ethics and Integrity Sub-Committee Report

9 Police and Crime Plan Performance Measures - Quarter 4 2022/23

The Panel received report EPFCP/12/23 which provided an overview of Essex Police's progress in delivering the priorities set out in the Police and Crime Plan, based on data and other information to the end of March 2023.

The Commissioner introduced the report and explained that this was set out in a new format with more data and trend analysis. He drew the Panel's attention to a number of highlights including completion of the Police Uplift Plan, progress in dealing with Anti-Social Behaviour, areas where more resources had been deployed, areas that had seen a downward trend and where there had been increases in solved rates and convictions. The Commissioner also highlighted the areas for continued focus which included public confidence in Essex Police, the areas of rural and business crime, the number of killed and seriously injured on the roads and specific recruitment campaigns.

During the discussion, the Panel asked questions and sought clarification on the following issues:

- A number of questions were raised in relation to the fall in overall confidence in Essex Police. It was explained that confidence in Police had increased during the pandemic due to more visibility and reductions in crime, but had started to fall again since then and this needed to be addressed. Local, visible policing and a focus on hotspots was key along with a focus on victim support and keeping victims informed. It was acknowledged that nationally issues with other police services could also have an impact on overall confidence in the Police.
- In relation to the reference in the report to an increase in the solved rates of hate crime, clarification was sought on the definition of hate crimes and hate speech.
- Confirmation was sought on how confident the Commissioner was that the downward trend in domestic abuse was a longer-term trend rather than less cases being reported. In response the Commissioner confirmed that investment had been made in better reporting and effective ways of victims getting in contact. The HMICFRS had rated the data accuracy as outstanding. There were cross checking processes in place to ensure that the reported crime and trends tallied with the independent surveys.
- A question was raised in relation to the reported decline in Anti-Social Behaviour, which was not felt to be the case in Castle Point. It was acknowledged that the reduction in Castle Point was significantly less of a reduction than in other areas. As this was an operational area it would be looked at outside of the Panel meeting.
- With regard to the conviction rates on sexual offences, it was reported that there had been some success in convictions. It was noted that in cases of rape there were issues around disputed cases of consent which was hard to prove. There was success in solving violent stranger rapes and homicides in the county. There was a lot of work being done to improve the support to victims including rapid response video approach. More work was needed in the prevention of rape and serious sexual assault and this was a national issue.
- In response to a query regarding what pilots were being run, the timescales and expected outcomes, particularly in relation to the Southend, Essex and Thurrock Domestic Abuse Board (SETDAB), it was suggested that a workshop session could be arranged to give an overview of the work of the SETDAB and in particular the pilot programs that were being run. An overview of the new pilots set out in the report

was given and the timescales were confirmed as running from the summer to March 2025.

- Information on the Anti-Social Behaviour (ASB) hotspot pilot was given, including how they were selected. There were 11 pilots running over 9 Community Safety Partnership (CSPs) areas. The details would be circulated to the Panel. If the pilot was successful it would then be the intention to roll it out nationally the following year which would give the opportunity to expand to other areas. The learning would be shared across all areas. The approach included working with partner agencies and CSPs. This was governed and overseen by Safer Essex.
- It was confirmed that with regard to the recruitment and retention of Specials, reasons for leaving were collected, many had gone on to be recruited as regulars. In the current economic climate it had been harder for people to give so many hours due to people having to work overtime and the recruitment market being active.
- The breakdown of the Killed and Seriously injured figures was given for the year. The Panel challenged whether the focus was in the right place regarding where accidents took place on the major or minor road networks. It was confirmed that the efforts were concentrated on the road areas where the accidents and harm were actually occurring. The Chairman advised that he had been invited to a Parliamentary event as the Chairman of the National Association of Police Fire and Crime Panels (NAPFCP) relating to young driver behaviour and would provide informal feedback to Panel Members.
- In terms of reducing drug-driven violence, the different ways of reporting crime, particularly anonymously were outlined. It was acknowledged that Fentanyl use posed a significant threat and the Commissioner outlined that work was being done to try and stop this being on the streets in Essex, working with the National Crime Agency.
- It was confirmed that Essex Police had a detailed operational procedure around pursuit of people on two-wheeled vehicles which would include e-scooters, e-bikes, bicycles and motorbikes, due to the risks involved.
- Clarification was sought on the references in the report to the increase in crime linked to individuals from Western Balkan countries and the impact in Essex. It was reported that the number of arrests in Essex was very low. There were Albanian organised criminal gangs in Essex linked to cannabis production. Agencies worked together to gather intelligence and intervene; 20 warrants had been conducted linked to that national effort.

The Commissioner agreed to give consideration to the following issues:

- Reporting back to the Panel on any material pilot programs
- Providing an update and information to the Panel on the ASB hotspot pilot
- Adding any Panel Members who requested it to the distribution list for receipt of the Newsletter that goes to Safer Essex.

Resolved:

1. That the Panel received and noted the report.

2. That the Panel add an item to the Forward Work Plan to receive via a workshop session, an overview of the work of the Southend, Essex and Thurrock Domestic Abuse Board, in particular the pilot programs that were being run, in relation to Priority 3 – Protecting vulnerable people and breaking the cycle of domestic abuse, of the Police and Crime Plan 2021-2024.

10 The 2024/25 Budget Setting Process

The Panel received report EPFCP/13/23 which provided the Panel with an outline of the 2024/25 budget setting process for the Police Fire and Crime Commissioner Fire and Rescue Authority (PFCCFRA) and the Police, Fire and Crime Commissioner (PFCC) for Essex (Essex Police).

The Commissioner introduced the report and advised that in previous years the Budget Setting Working Group had been invaluable to the Budget Setting process and invited the Panel to establish a working group for this period.

Resolved:

1. That the Panel received and noted the report and accepted the Police, Fire and Crime Commissioner's invitation to participate in this process through the creation of a 2024/25 Budget Setting Working Group of the Panel, in line with the process established for 2023/24 budget setting.
2. That the membership and dates of the Working Group would be confirmed after the meeting.

11 Police, Fire and Crime Commissioner's Decisions Reports

The Panel received and raised questions on report EPFCP/14/23 which provided information about financial and strategic decisions made by the PFCC.
