Local Authorities have a duty under Section 22A of the Children Act (1989) to provide accommodation for a looked after child or young person. ECC is, therefore, the 'corporate parent' for these children and young people. The Inside Out (ISO) coaching programme offers intensive support to young people in care (13-17 years). The programme aims to provide the critical scaffolding to support a positive transition into adulthood. An ISO coach works 1:1 with the young person to establish a sense of stability by way of a positive relationship, encouragement to make positive decisions and build resilience to better face setbacks should they occur.

Inside Out was funded by the Department for Education Innovation Programme from April 2018 and this funding ceases on 30th June 2022. A decision was approved by Cabinet in July 2021 to launch a tender to commission a continued ISO service. The tender was subsequently launched in late 2021 and has now been evaluated. This EQIA supports the CMA to agree the awarding of the contract.

The programme is targeted for the most vulnerable young people in care, who have experienced multiple placement breakdowns and challenges in their lives. The characteristics of this cohort are that they have multiple complex needs including substance misuse; mental health problems;

being at risk of CSE; offending behaviour; gang involvement; being not in education employment or training (NEET). The majority were white British and the average age was just over 15.

The programme was externally evaluated by the Tavistock Institute (

https://assets.publishing.service.gov.uk/government/uploads/system/uploads/attachment\_data/file/932752/Essex\_l Tavistock.pdf ) which has evidenced positive impacts in terms of increasing stability, improving mental health

and wellbeing and reducing behaviours that expose the young person to risks.

Nature of impact: Positive

Please provide more details about the nature of impact: The independent evaluation of the programme has evidenced the positive impact on outcomes for the target cohort of children in care aged between 13 and 17. The service is therefore reducing the disadvantage experienced by this group at a key age when they are approaching independence and adulthood.

**Extent of impact:** Medium

Please provide more details about the extent of impact: Evidence from the evaluation has shown improvements in placement stability for the cohort, as well as improvements in mental health and wellbeing and reductions in behaviours that expose the young person to risk.

## **Disability - learning disability**

Nature of impact: Positive

Please provide more details about the nature of impact: Data analysis from the programme has shown that a large number of young people on the programme present with some level of cognitive delay associated with their experience of trauma/undiagnosed Learning Disabilities/instability and/or missing education.

The service is targeted to support this cohort of young people therefore has a positive overall impact.

Please provide more details about the extent of impact: The extent of the positive impact is low, as not all young people have a learning disability or a diagnosis, however the service is able to support them where they present with some level of cognitive delay.

## Disability - mental health issues

Nature of impact: Positive

Please provide more details about the nature of impact: The independent evaluation has evidenced improvements in young people's mental health and emotional wellbeing. As a cohort, the target group are highly traumatised and vulnerable, therefore a positive impact has been identified for this group in particular.

**Extent of impact:** Medium

Please provide more details about the extent of impact: A medium positive impact is identified as the external evaluation noted that discussions with participants indicated a positive impact of them becoming happier, calmer, less anxious and more reflective about their own behaviour.
