### Executive summary

**Title of policy or decision:** Coronavirus Outbreak – Temporary Closure of Park and Ride services

**Describe the main aims, objectives and purpose of the policy (or decision):** The Coronavirus outbreak is a major public health emergency. The Government's current advice is for the population of the United Kingdom to travel only when it is essential to do so.

As a result the number of passengers using the Park and Ride services has dropped significantly.

In addition, the number of critical workers available to run passenger transport services is dropping. Closing these sites will allow these critical workers to be re-deployed onto other bus services providing transport to hospitals.
