## 1 Purpose of Report

1.1 This report introduces the Organisation Aims Report (OAR) on performance from the Everyone's Essex performance framework for Quarter 1 2022-23. The report is provided as an annex to this paper and outlines performance of agreed strategic measures for April to June 2022.

- 1.2 The OAR is prepared on a quarterly basis. The report is designed to:
  - help monitor progress towards the delivery of the organisation's strategic aims; and
  - enable the Chief Executive to discharge his responsibilities towards the council.
- 1.3 The report also includes an outline of the measures which will be updated in future reporting periods.

## 3 Summary

- 3.1. The Everyone's Essex performance framework was agreed by Full Council in October 2021, and outlines measures aligned with the strategic aims.
- 3.2 The performance reporting in-year focusses on the strategic measures, which provide a link with the aims of ECC, and relate to measures that are directly linked with interventions of the council.

3.3 This report does not cover contextual measures which the Council has an interest in but which are not under its direct control (or the control of any one other organisation) and operational measures which are reported directly to the functions and used by services and portfolio holders to manage services.

#### 4 Headlines

- 4.1 Performance in most areas continues to be strong, and areas to note in the first quarter of 2022/23 include:
  - ECC's programme in partnership with ACL has generated significant increases in people seeking qualifications. The target for the year was 1720 and over 1,000 have signed up in this quarter alone.
  - Health checks for people aged over 40 have increased substantially and are now over target. Discussions are underway to stretch this target to 42,000.
  - Entry level jobs created through our social value scheme in our contracts has exceeded expectations.
  - All ECC estates are now on 'green' tariffs. In addition, although not strictly Q1
    performance, we have recently been awarded an 'A' status carbon rating based
    on the Carbon Disclosure Project assessment. We were 'B' when we set the
    measure and were pitching to reach 'A' by the end of the Council period. We
    are the only county council in the country that has achieved this rating.
  - The council tax collection outturn for 2021/22 has now been confirmed at nearly 97%. This is being closely reviewed by finance as changes in household bills may have an impact on collection rates in the coming months.
- 4.2 Performance in some areas is not meeting targets, and is being reviewed actively by functions:
  - Physical activity (as monitored by national surveys) has decreased. There are a range of interventions that are being actively pursued by ECC and across the wider Essex footprint.
  - ASC continues to experience supply issues with the delivery of some services.
  - The bi-annual results of the carers survey have also been completed this
    quarter, and this has identified a reduction in satisfaction for carers. Although in
    line with reductions seen at a national level, addressing this will form part of the
    carers' strategy which is currently in development.
  - Home retrofitting in Q1 was largely paused while external funding was confirmed. This has now re-started and ECC is supporting the South East Partnership who deliver this in Essex.
  - Re-offending in youth offending while lower than in previous years (partly as crime reduced during lockdowns), has seen those that do re-offend committing more crime.

The measures in the framework continue to be kept under review. In particular, we are exploring the feasibility of strengthening our ability to stratify the data by cohort and geographies.

## 5. Change control process

At the July scrutiny (when the performance outturn was last considered), it was noted by the committee that we had introduced a 'change control' process, and that measures considered through that process were also brought to the attention of the committee to ensure transparency.

Outlined below are the measures that were proposed and agreed through this quarter. These are not yet reflected in the tables, and will be updated against Quarter 2 outturns.

## ECC Electricity from renewable sources

All ECC buildings have now secured electricity from renewable sources through their contracts. Future reporting will review progress against on-site (i.e. self generated) renewables.

## Flooding schemes

The original target was set before detailed planning of the schemes was able to be undertaken. Planned works will see 8 schemes completed this financial year.

## Retrofit low income housing

This measure is dependent on external funding, which has now been secured. New 2022/23 target of 2758 has been set (was previously 0) as new funding streams will enable significant programmes to roll out.

## Essex Housing and Independent living availability

Timing of schemes has been confirmed. In 2022/23 the focus is on Master plans, starting on site and planning consent to progress builds for completion 23/24 and 24/25. The cumulative target by the end of the strategy period (2025) remains unchanged.

### Infrastructure

Proposed new measure to be included for future quarters that looks at roads where maintenance should be considered.

## Mental health accommodation and employment

The national definitions for these measures have been changed, and require reframing to ensure that we are able to use comparable data.

As this target has now been met, it is proposed to shift focus to electricity from 100% onsite renewables.  Additionally, solar panels have been installed across 52 buildings on the ECC estate including schools. These solar panels have already generated 1,300,000kWh, saving 286 tonnes of C02 in 2022 and saved schools £63,710 in energy costs.  We have also reduced ECC core estate GHG emissions from 6010 (MtCO2e) in 2020/21, to 5961 in 21/22, despite increases in staff volume in offices and services accessed by residents.
Retrofit in low income households	N/A	1	-	N/A	Retrofitting is dependent on external funding to complete. A gap in confirmed funding for retrofitting schemes resulted in a pause in schemes delivered. New funding streams have been confirmed and will help us deliver a new programme in 2022/23. Interest is understandably high. ECC has launched a Retrofit Academy to train trainers and upskill people within the supply chain to meet the demand in this area.

It is expected that this rate will increase in subsequent years.

So while far fewer individuals have re-offended, they have committed more offences. This is based on a frequency of 113 new offences.

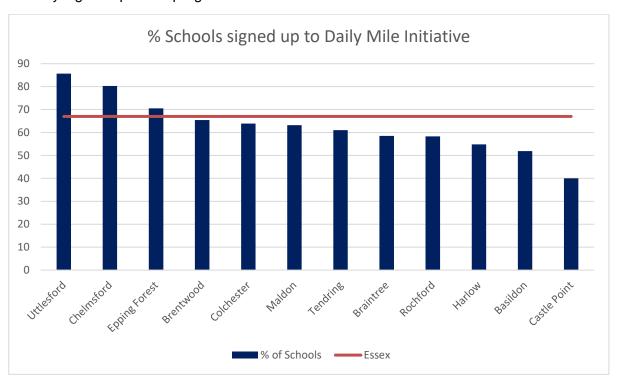
# SERVICE EXCELLENCE

Collection rate of Council Tax achieved for this year	96% (2020/21)	96.9% (2021/22)	96%	Green	Essex County Council has historically achieved a collection rate of between 97% and 98% over the last ten years. In 2021/22, the collection rate improved from the previous year and almost reached 97%. Although the current trajectory suggests ECC's collection rate will meet the 98% target in the near future, sharp increases in inflation and the cost of living might create financial challenges for Essex residents and this could have an adverse impact on the collection of council tax for 2022/23.

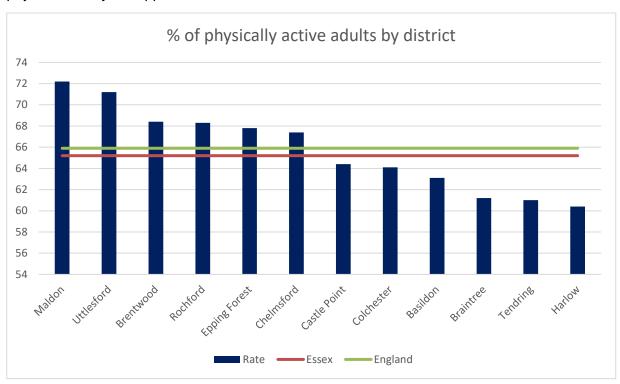
## Daily Mile - Percentage of schools signed up to the daily mile initiative.

There is a 45 point difference between the area with the highest number of schools signed up, and the lowest. Some schools report that their pupils undertake a daily mile, but are not formally signed up to the programme.



## Physical activity - Percentage of adults reporting that they are physically active

There is also a wide range of variability in adults reporting that they are physically active. The programmes outlined in the paper are also looking at barriers to engagement in all forms of physical activity to support the health of Essex residents.



# "NEET" – Percentage of young people aged 16-18 not in education, employment or training

On average, young people in Essex are more likely to be in education, employment or training than the rest of England. However, this varies between areas, and Harlow and Tendring both have rates of NEETs significantly higher than the England average.
