It is understood that at July full Council there may be a change in the HOSC membership namely Councillor Anne Brown (Colchester/ Constable) will replace Councillor Jeff Henry.

In addition, Article 10 of the Council's Constitution permits the appointment of up to four co-opted non-voting members, at the invitation of the Committee, on the nomination of other Essex local authorities - primarily to ensure that all twelve council administrative areas in Essex are represented on the HOSC either by a County Councillor or District Councillor.

Based upon the new County Councillor membership of the HOSC, there is no representation from the administrative areas of Brentwood, Harlow, Maldon, and Uttlesford moving forward. In consultation with the Chairman, the local councils have been invited to nominate a representative to sit on the HOSC as a co-opted non-voting member for the year ahead.
