

# Public notice

## **The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.18) Order 202\***

**Notice is hereby given** that Essex County Council proposes to make the above Order under Sections 1(1), 2(1) to (4), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

### **The effect of the Order:**

1. To replace the existing Limited Waiting Mon-Sat 8am-6pm 1 hour no return within 3 hours with No Waiting at Any Time restrictions (existing layby to be removed and footway/kerb to be reinstated) on Victoria Road in the City of Chelmsford, North side: From a point approximately 2.4 metres west of the western property boundary of No.73 Victoria Road, east for approximately 37.65 metres.
2. To replace a length of existing No Waiting at Any Time restrictions with a Goods Vehicles Loading Only (to be located within designated layby) on Victoria Road in the City of Chelmsford, North side: From a point approximately 1.83 metres east of the shared property boundary of No. 63 & No.64 Victoria Road, east for approximately 20 metres.

This Order will be incorporated into The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by substituting tile numbers TL705 070 revision 1 to revision 2, TL710 070 revision 0 to revision 1.
