2.1	Is this a new policy (or decision) or a change to an existing policy, practice or project? New project	
2.2	Describe the main aims, objectives and purpose of the policy (or decision): This proposal is driven by the County Council's Organisation Strategy to deliver the	
	best possible educational outcomes for children attending schools within its administrative border, in this particular case those at Mayflower Primary School, Harwich.	
	What outcome(s) are you hoping to achieve (ie decommissioning or commissioning a service)?	
	The Harwich and Dovercourt area has experienced a rise in the demand for primary school places in the last few years as a result of births, families moving in and new housing. Latest forecasts indicate continued growth in pupil numbers and additional provision is required to balance future supply and demand for local reception year places.	
	Essex County Council must meet its statutory duty to ensure that each child within its administrative border has a school place available to them. As part of a package of measures coming forward to meet the forecast demand, the governing body of Mayflower Primary School agreed to a consultion with the community on the expansion of the school to accommodate an additional 70 pupils, increasing its overall capacity to 420 pupils.

	Being an expansion there will be no adverse impact upon any of those groups mentioned above. However, should additional places not be delivered for September 2019 there is a significant risk that children will be without school places in their local area, that longer journeys will need to be made between home and school in order to find alternative schools with spaces and that in an increased number of cases parental preference will not be satisfied.
	The building works will be procured by the County Council using framework agreements which it is entitled to use. Contractors experienced in working on projects of this type will be used.
	The premises to be provided will need to meet the statutory requirements of the Education (School Premises) Regulations 1999 and the feasibility studies and the final programme will ensure that this happens.
	As public buildings, schools are required to provide full accessibility in order to obtain Building Control sign-off. Essex County Council produces a set of employer's requirements which add further interpretation to ensure this is achieved from the early stages of design. Prior to planning permission application Building Control approval is sought to offer earlier compliance confirmation. Any works to expand the building will be fully compliant with the legislation. This builds in a future-proofing dimension to our buildings, ensuring they are accessible for disabled users.
	As part of the refurbishment works proposed for the existing building a lift will be brought back into use. This will provide better access to the first and second floor of the building and will be an improvement on the existing provision.

	No resources are reduced or withdrawn by the expansion of a school. Rather, there is appropriate capital investement to accommodate additional pupils and, school funding being largely pupil-led, these pupils generate additional resources for the school.

3.1	What does the information tell you about those groups identified? The percentage of pupils at Mayflower Primary School in January 2018 who were identified as White British was 88.0%, compared with a figure of 84.1% accross the district of Tendring as a whole in the same age range. The expansion will increase the number of pupils to be admitted each year. It will not change the arrangements for admission to Reception year (beyond making more places available and thereby potentially better satisfying parental preference, as previously stated). A larger number of children from the same community will therefore have the opportunity to access education at Mayflower Primary School. There is no reason to suggest that the proposed expansion of the school will affect the population mix directly.
3.2	<ul> <li>Have you consulted or involved those groups that are likely to be affected by the policy or decision you want to implement? If so, what were their views and how have their views influenced your decision?</li> <li>A public consultation on the proposed expansion was undertaken between 22 November 2018 and 20 December 2018. A large number of individuals and groups were consulted, which included all local members on Essex County Council, Tendring District Council, all schools within Tendring District, Trade Unions, as well as parents/ carers, staff and pupils at the school concerned. A public drop-in session – the time and date for which being advertised in a number of ways, including the local press - was held at the school. Significant engagement with all interested parties was encouraged. Feedback at the meetings and from the consultation were supportive of the proposed expansion.</li> </ul>
