## **Executive summary**

**Title of policy / decision:** Approval of Community Challenge Fund (CCF) Applications with Amendments to Eligibility Criteria and Upper Grant Award Limit

Policy / decision type: Cabinet Member Action (CMA)

Overview of policy / decision: Following a decision made in December 2021 the Council established a £500,000 fund called the Community Challenge Fund. The Council has established criteria for making grants under this Fund. The Community Challenge Fund seeks to support new, not for profit schemes, groups, initiatives or ideas. Small scale community projects between the value of £300 - £5,000. The fund is specifically targeted at communities in the identified levelling up areas of Clacton, Harwich, Canvey, Harlow, Rural Braintree and parts of Colchester and Basildon.

The decision set out in the paper sees the Deputy Leader and Cabinet Member for Community, Equality, Partnerships and Performance agreeing to make grants from the Community Challenge Fund (CCF) set out in the appendix to the decision paper.

It also sets the terms that no payments will be made with respect to a particular grant, unless the recipient agrees to the terms and conditions of grant.

What outcome(s) are you hoping to achieve?: The Community Challenge Fund has been created to provide a straightforward and speedy way for local residents, registered charities, community interest companies and charitable incorporated organisations to access small amounts of money to support their community. Working across the areas that The Council has prioritised in terms of Levelling Up. Grants will support projects that encourage different groups within communities to meet and come together as well as applications that consider those in the community who might be less engaged or on the periphery.

Applications that seek to spread opportunities within the community, share experiences and skills or create places or spaces where people are happy to spend time will also be supported where these meet the eligibility criteria.

- -Outcomes that the decision will achieve include:-
- -Engaging people in their local community
- -Developing last and positive change at a community level
- -Addressing isolation and loneliness
- -Building community capacity, activism and assets
- -Creating places individuals and communities are proud to celebrate.

Rationale for assessment, including data used to assess the impact: The decision making process that will be established on the back of this decision will directly benefit the six priority areas for Levelling Up. Including Harlow, Basildon, Tendring, Castle Point, Colchester and Rural areas of Braintree.

The core geographical focus of ECC's levelling-up programme has been determined by working through the following steps:

Step 1: Identifying the most deprived districts in Essex (based on IMD 2019)

Step 2: Identifying the most deprived LSOAs within these districts (Based on IMD 2019)

These core LSOAs provide the geographical focus for the design of any specific policy interventions and will be used as a default geographical unit for analytical purposes. In the interests of effective policy implementation, small-area geographies that either a) contain these LSOAs and neighbouring areas; or b) are contained within these LSOAs, c) adjacent to these areas (or the areas they are contained within), may be used as a focus for the delivery of interventions.

This will be particularly important where there is an need to:

- ensure that geographies are recognisable to, and resonate with, local communities. LSOAs are a statistical construct developed top-down by the ONS and do not reflect residents understanding of their local areas;
- ensure alignment with local democratic structures (e.g. wards).

We have identified rural Braintree as an area that exemplifies the challenges associated with poor connectivity, rural isolation and poor access to services.
