1. Purpose of the Report

3. Draft Accounts 2011/12

- 3.1 The draft County Council Accounts for 2011/12 (incorporating draft Pension Fund financial statements) have been prepared and were submitted to the Audit Committee on 29 June 2012.
- 3.2 Colleagues from the Audit Commission commenced the external audit on 25 June 2012. The formal conclusion of the audit is scheduled for September 2012.
- 3.3 A copy of the Pension Fund's draft financial statements for 2011/12 is attached at Appendix 2. The accounts are formatted as they will appear within the 2011/12 Essex County Council Statement of Accounts.

4. Pension Fund Annual Report publication

- 4.1 Under the Local Authority Pension Scheme (Administration) Regulations 2008 a Pension Fund Annual Report is required to be published by 1 December 2012.
- 4.2 In addition to the financial statements, a number of other documents are required to be included within the Annual Report (e.g. the Funding Strategy Statement, Governance Compliance Statement, Communications Policy Statement, Knowledge and Skill Compliance Statement & Statement of Investment Principles).
- 4.3 Work is currently underway on compiling the Annual Report and a full list of the contents is attached at Appendix 1. When work has been completed a final draft will be submitted to the Essex Pension Board Chairman for approval. Subsequently a copy of the approved Annual Report will be sent to all Board Members.
