

The Conference

The seventh annual LGPS trustees' conference, themed "2010 – Is the writing on the wall?", is to be held on 22 and 23 October 2009 at the Marriott Hotel, Mill Lane, Cardiff commencing with a buffet lunch at 12:30pm. The first of the afternoon sessions will commence at 13:50pm. Following the afternoon programme there will be a drinks reception in the evening and a private conference dinner with an after-dinner speaker. Overnight accommodation and breakfast at the Marriott is also included in the conference fee. The second day consists of a full morning's programme concluding with a buffet lunch for delegates at 12:30pm. This format has been appreciated by previous delegates, as it allows plenty of time for travel and avoids the expense of an extra nights' accommodation in many cases. However, the LGPC Secretariat has secured a limited number of rooms for the night of 21 October at a reduced rate.
