#### **Executive summary**

**Title of policy or decision:** To approve the ongoing funding for the Future of Volunteering Project

**Describe the main aims, objectives and purpose of the policy (or decision):** The aim of this project is to develop a new volunteering system for Essex that helps channel the energy of our communities, and build a model that is fit for purpose and can meet the demands of the community. We aim to develop an approach that:

- Enables volunteers to volunteer in a flexible way within a fluid volunteering system where volunteers can passport easily into opportunities across the system
- Embeds a US style Community Emergency Response Team [CERT] model that stands-up volunteers who are stood down if not required. Building a "Local Resilience Capability" for Essex.
- A whole system approach that encompasses individual volunteering alongside corporate volunteering.
- Underpinned by technology that can match both people and kit resources to meet needs within the system.

This is a great opportunity for young adults to have career pathways into partner organisations. Partner organisations such as the Police, Fire Service, EWS and Community Voluntary Services (CVS) will all be part of this model, therefore a volunteer could carry out a role with any of these organisations. They will be able to acquire new skills and experience through the training and development scheme we will provide, hence building their social CV which could lead to employment opportunities.

It also allows us to help those vulnerable members of our communities that need additional support and care. By providing this care through volunteers we are reducing the visits to GPs, A&E, and other statutory services who would have had to deal with requests from the community in the absence of another provider. Volunteers carry out key roles such as picking up medication, delivering shopping for those vulnerable members of the community, gardening, providing transport, offering a befriending service and providing transport so people can get to medical appointments. Research has shown that one of the main reasons we had such a high response to volunteering during COVID was the volunteer roles were less specialised than previous ones so there was a lower barrier to entry which attracted more people from the community to volunteer.
