

# **Essex Climate Action Commission**

## **Terms of Reference**

### **Background**

The creation of an Essex Climate Action Commission (ECAC) was announced at Full Council in October 2019 by the (then) Leader of Essex County Council (ECC). It was originally agreed to run for two years with the following purpose:

- Year One: Identify ways in which Essex County Council (ECC) can mitigate
  the effects of climate change, improve air quality, reduce waste across Essex
  and increase the amount of green infrastructure and biodiversity in the county
  by drawing on in-house expertise, commissioning research and forming new
  external partnerships.
- Year Two: Explore how we attract investment in natural capital and lowcarbon growth.

In February 2022, Cllr Kevin Bentley, the Leader of Essex County Council (ECC) agreed to extend the life of the Commission to May 2025.

## **Purpose**

The purpose of the Commission to May 2025 is to monitor and drive implementation of the recommendations on the race to net zero across greater Essex by:

- Advising on priorities for direction in the focus areas of the Special Interest Groups;
- Reviewing and evaluating progress towards Net Zero;
- Supporting the adoption of climate positive policies and practices at all levels of local authorities in the region;
- Facilitating collective action across the county;
- Encouraging public engagement with residents, businesses, schools, communities, third sector organisations and other institutions of Essex.

Work plans for the Commission will be set out and agreed by the Commission for each year of activity. The work plan for 2023 is set out in Annex 2.

#### **Timeline**

The Commission will run to May 2025 to align with Essex County Council's current administration and could then be extended.

### Membership

The membership of the Commission is set out in Annex 1.

Membership of the Commission is not expected to be static. New members may be invited to join the Commission to support the delivery of the best outcomes and recommendations. This will be in consultation with Commission Chair and Members, ECC's Director of Environment and Climate Action and agreed by ECC's Chief Executive and the Chair.

#### Quorum

Seven members, including the Chair, should be present, either physically or virtually (via an online meeting), for the Commission to sit.

#### **Secretariat**

The Commission will be supported by a Secretariat.

### **Meeting Frequency**

The Commission will meet at least quarterly.

The Commission has special interest sub-groups that meet more regularly to explore specific themes/topics in more detail.

Meetings of the Commission should take place online, however the Commission may convene in Essex or London from time to time if there is a specific reason to do so.

Meetings will be recorded for public dissemination. Commission members should note that all discussions in the main Commission meetings will, unless by exception to be agreed in advance by the Chair, be released into the public domain.

#### **Advisory status**

The Commission is an advisory body and has no decision-making powers. Formal decisions to implement any recommendations made by the Commission within Essex County Council will be taken and actioned in accordance with the ECC Constitution.
