The purpose of this report is to consider the Committee's latest work programme, which is set out at Appendix A to this report.

The following items are drawn to the Committee's attention:

1. Scrutiny Review on Banking on Essex

This review is scheduled for 24 February 2011, and a draft scoping document is attached at Appendix B for the Committee's approval.

2. Scrutiny Review on Post Office Initiative

This review is scheduled for 24 February 2011, and a draft scoping document is attached at Appendix C for the Committee's approval.

3. Scrutiny Review on Corporate Carbon Reduction

The Committee agreed in September 2010 (Minute 44) that this review should be taken forward by a Task and Finish Group, which will be led by Councillor McEwen. Councillors Aspinell and Kendall have also indicated that they wish to be on the Group. Please could any other Members who wish to join the Group advise Councillor McEwen accordingly.

A draft scoping document is in the process of being drafted for this review.

4. Scrutiny Review on Generation of Energy/ Renewable Energy

Recently full Committee resolved 'to continue to review the opportunities for generating green energy including solid recovered fuel as part of the Task and Finish Group

established by the Economic Development and Environment Policy and Scrutiny Committee. To report back to Cabinet following that review having evaluated what green energy options could be actively pursued based on a sound financial business case.'

It is proposed that the following the review on Corporate Carbon Reduction referred to above, steps will be taken to take Council's proposed review forward.

It is notable that the Committee has already embarked upon a review on the 'Generation of Energy', and the information obtained is set out in a series of evidence sheets. It was agreed in the summer that that review would be taken forward pending the development of the original scoping document (reference EDE-SCR-17). Consequently the latest proposal may be able to build upon the evidence already obtained by Members.

5. Highways Service Transformation Programme

After full Council on 14 December Members have been invited to a briefing organised by the Cabinet Member for Highways and Transportation on the Highways Service Transformation Programme. Committee Members are encouraged to take part in that briefing as the issues being raised will be pertinent to this particular Forward Look.
