### Executive summary

**Title of policy or decision:** SELEP Getting Building Fund: Shovel Ready Projects Approval

**Describe the main aims, objectives and purpose of the policy (or decision):** The Getting Building Fund was launched by Government as a response to the secondary economic impacts of the COVID-19 lockdown. LEPs were asked to submit a list of potential projects in the first instance, which were reviewed, approved by MHCLG. A guidance on prioritisation was also submitted by MHCLG, which the SELEP Strategic Board took into consideration when allocating funding.

The 13 Essex projects were selected based on their deliverability within the short timescales and their impact in creating jobs and supporting the economic recovery.
