### **Executive summary**

Title of policy or decision: Adoption and release of the updated 'Essex SuDS Design Guide (2020)'

**Describe the main aims, objectives and purpose of the policy (or decision):** The main aim of the 'Essex SuDS Design Guide (2020)' is to allow applicants to the planning process access to the Lead Local Flood Authorities' (LLFAs) most current requirements on mitigating the potential flood risk impacts of new development through provision of good quality SuDS. This guide will result in improved quality of information submitted with planning applications and a subsequent reduction in the number of Holding Objections raised by the LLFAs in response to requests for consultation.

With Local Planning Authorities (LPAs) across Essex preparing Local Development Plans to deliver over 140,000 additional homes up to 2036, provision of good quality SuDS is essential for ensuring flood risk is not increased and the additional benefits such as water quality, amenity and biodiversity are realised.

We are hoping Essex County Council will agree to adopt and release the updated 'Essex SuDS Design Guide (2020)' in both print document and website formats for general use to the public.

We have consulted with both Internal and External Stakeholders and feedback received has been positive, in favour of releasing the updated version of the Design Guide, particularly the Web-based format. Feedback was received from key Stakeholders (Inc. Developers, Consultants and Planners) at an open workshop held on 25/09/2019 and details incorporated into the final version of the Design Guide where necessary.

It was felt that the workshop held on 25/09/2019 represented a broad cross section of Stakeholders, however, undoubtedly would not capture them all. On release of the Design Guide, the LLFA will continue to review/ receive feedback from Stakeholders and make amendments to content of the Design Guide where this is necessary.
