

# Equality Impact Assessment

3.1	<p>What does the information tell you about those groups identified?</p> <p><b>Tendring is the fourth largest district in Essex in terms of total population and in 2016, it accounted for 7% of the total County population. It has one main urban area, Clacton-on-Sea. Tendring has a high proportion of over 65's and 17% increase is expected between 2012 and 2022 equating to 6,900 more residents. The working population is essential for economic growth and requires adequate housing, access to jobs/businesses and good highway links. The district attracts many tourists to the seaside areas of Clacton, Frinton &amp; Walton and Brightlingsea.</b></p>
3.2	<p>Have you consulted or involved those groups that are likely to be affected by the policy or decision you want to implement? If so, what were their views and how have their views influenced your decision?</p> <p><b>Eight County Councillors and four District Councillors represent the views of local Residents on the LHP. The Councillors not only represents the views of local Residents but also Parish/Town Councils and other bodies, such as Housing Associations.</b></p>
