Essex County Council and Committees Information

All Council and Committee Meetings are held in public unless the business is exempt in accordance with the requirements of the Local Government Act 1972. If there is exempted business, it will be clearly marked as an Exempt Item on the agenda and members of the public and any representatives of the media will be asked to leave the meeting room for that item.

Attendance at meetings

Most meetings are held at County Hall, Chelmsford, CM1 1LX. <u>A map and directions to County Hall can be found on our website.</u>

Access to the meeting and reasonable adjustments

County Hall is accessible via ramped access to the building for people with physical disabilities. The Council Chamber and Committee Rooms are accessible by lift and are located on the first and second floors of County Hall.

Induction loop facilities are available in most Meeting Rooms. Specialist headsets are available from Reception.

The public are entitled to be admitted to the meeting but as space for the public is extremely limited due to COVID secure requirements it is likely that the members of the public will only get a limited view of proceedings and would get a better view by watching on YouTube.

Appointment of Honorary Aldermen

In October 2004, the Council approved a Scheme to confer the title of honorary alderman on:

- all individuals who have previously held the Office of Chairman of the County Council and are no longer Members of the County Council;
- a small number of individuals in each four-year cycle to recognise the contribution of retiring Members who have rendered eminent service to the Council, but who have not held the Office of Chairman.

The Council's approval is sought to confer the title of Honorary Alderman on those individuals, as recommended below. The legal requirement for the appointment of Honorary Aldermen is that the resolution in respect of each nomination must be passed by two-thirds of the Members voting at the meeting.
