**Use this section to record how you have assessed any potential impact on the communities likely to be affected by the policy (or decision):** Further to a request from Harlow District Council (HDC) to renew the joint HDC/ECC injunction application a pros and cons and implications analysis has been undertaken, which forms the basis of the content of the main CMA document. The injunction seeks to prevent people setting up encampments which are neither authorised nor lawful, and is based on significant previous problems caused by unauthorised encampments in Harlow district which included significant antisocial behaviour and environmental damage. Analysis for this CMA included: review of injunctions against unauthorised encampments in other parts of the country and recent court rulings/precedents, analysis of whether the injunction is proportionate to the issue it seeks to remedy, the wider Essex County context, including the partnership work undertaken by the Essex Countywide Traveller Unit partnership.

**Please provide more details about the nature of impact:** Whilst the injunction seeks to prevent those who engage in unauthorised encampments from doing so, the activity which the injunction sees to address is unlawful. there is therefore no adverse impact on activity which is lawful, so the impact has been recorded as low

**Extent of impact:** Low

**Please provide more details about the extent of impact:** This is a renewal of an existing injunction so is a continuation of activity which is already prevented through the injunction, rather than a substantial change to existing methods of how unauthorised encampments are dealt with in Harlow. As a mitigating factor ECC has formally requested that Harlow District Council join the Essex Countywide Traveller Unit, long with other tier 2 authorities in Essex, to support consistent arrangements for welfare for any GRT communities in unauthorised encampments in Harlow, so that enforcement is proportionately balanced with welfare considerations.
