

# Equality Impact Assessment

3.1	<p>What does the information tell you about those groups identified?</p> <p><b>Rochford covers an area of 65 square miles and is predominantly rural in its character. It has miles of coastline as well as vast areas of countryside. The small outlying villages and towns offer both rural and semi-rural living. These are still within easy reach of the main centres and the mainline railway. Rochford is the third smallest district in Essex in terms of total population numbers, accounting for 5.9% of the total population in Essex. It has a slightly lower proportion of over 65s compared to the county as a whole although a 19% increase is expected between 2015 and 2025 equating to 3,680 more people. This ageing population will put greater demand on health, social care services and housing needs. The working population is essential for economic growth, requiring adequate housing, access to jobs and businesses, and the Rochford proportion is forecast to decrease by three percentage points by 2024.</b></p>

If so, what were their views and how have their views influenced your decision?</p> <p><b>The views of local Residents are represented on the LHP by a Parish Councillor, four District Councillors and all County Councillors. The Councillors not only represent the views of local Residents but also Parish/Town Councils and other bodies, such as Housing Associations.</b></p>
