This will also strengthen its relationship with service users and other agencies involved with CAMHS. ▪ There are approximately 253,000 children over the age of five years old in Essex. At least 10% of these have a diagnosable mental health disorder. It is essential; therefore, that the service is reviewed to ensure it provides an adequate service for these young people. ▪ Members will be seen to have examined the adequacy of the Council's ability to assist young people with mental health disorders. ▪ There will either be recognition that service delivery is acceptable or gaps identified and recommendations developed to improve services.
