## 3 Minutes: 26.01.22

The Minutes of the meeting held on 26th January 2022 were approved as a correct record.

Cllr Turner requested an update on OFWAT attending a future meeting of the Board. Lucy Shepherd advised that she had recently changed roles and that this action had now been handed to Marc Inman who would chase in this regard.

#### 4 Essex Water Strategy

The Board received a presentation from Lucy Shepherd, Lead Local Flood Authority Manager regarding the upcoming Essex Water Strategy scoping study. The presentation illustrated the problem between water supply and demand, how the problem will grow and potential solutions.

A Slido question live survey was conducted following the presentation, with the link to the same provided to Members following the meeting

Cllr Turner advised that he has weather stations within his District which indicated that there were no issues with water shortages. He believed that the issue lay with water companies and their procedures for water collection. Lucy Shepherd confirmed that there needed to be more engagement with the water companies and that work was in progress in this regard.

Cllr White felt that there as a major issue with new housing developments and associated planning permissions. She believed that there is too much red tape and that was a greater need for collaborative working.

John Meehan stressed that national and global agencies are predicting future water shortages and that lowering levels of rainfall were creating issues.

Cllr Wexham stated that in his area there were issues with the availability of water supplies.

Cllr Scott asked that the above issues be added as a future agenda item.

#### 5 Highways Floods Enforcement Officer

Lucy Shepherd advised that a new Highways Flood enforcement officer had recently been appointed and there was the intention to invite the team/officer to a future Board meeting.

Cllr Scott stated that this was excellent news and a welcome appointment which was greatly assist with enforcement issues.

Cllr Wexham enquired as to how this appointment would tie in with Southend on Sea Borough Council and Thurrock Council, which are both unintaries. Cllr Scott advised that at this stage he was not able to confirm but that he felt that as this was an Essex County Council (ECC) appointment it may be restricted to the Districts within the County. Lucy Shepherd agreed to investigate it and confirm the position.

Following the meeting it was confirmed that the Highways Enforcement Officer is an ECC employee only. Southend and Thurrock hold highways and land drainage responsibilities and Cllrs should speak to their in-house Flood Teams for further advice. ECC regularly communicate, sharing experience and approaches via the Executive Flood Officers Group (more info at <u>https://www.southend.gov.uk/flooding-1</u> and <u>https://www.thurrock.gov.uk/flood-risks/overview</u>).

#### 6 Essex Capital Flood Programme and Essex Forestry Initiative

The Board received a report **EFPB/02/22** from Dave Chapman, Project Delivery Manager, on the progress of schemes in the Floods Capital Programme. This was followed by a presentation on the Essex Forestry Initiative end of year review.

The following issues were raised by members:

- Allocated maintenance- it was confirmed that this was done on a case by case basis depending upon the site in question
- Maintenance is key if trees are to survive this was agreed
- Whether tree planting was too simplistic, with there being a need to work with drought issues- it was confirmed that an environmental assessment is carried out prior to planting.

Cllr Turner enquired as to whether there were any additional trees available for an area within his Division. Dave Chapman confirmed that he would make contact following the meeting.
