I appreciate your concerns in relation to the safety of cyclists however the implementation of a cycle lane is outside the scope of the current proposal.</p> <p>If you feel strongly in relation to the implementation of a cycle lane at this location this would need to be raised with your local county member to be raised at Castle Point Local Highways panel. It is also proposed to implement a no entry on the new exit slip to prevent vehicles travelling eastbound on the A13 London road turning left in to oncoming traffic using the new exit lane.</p> <p>I note your comments in relation to vehicles mistakenly believe the existing exit road from Morrisons carpark on to New Road is 2 way. Further investigations will be made in relation to this to ascertain whether additional measures can be made to prevent this from occurring.
