Title of policy or decision: FP/409/04/19

Describe the main aims, objectives and purpose of the policy (or decision): To seek approval to extend 76 local bus contracts due to expire in July 2020 for an additional 12 months.

To seek approval to undertake a procurement exercise and award to replace those contracts where the current provider declines to extend the current services for a period of 12 months.

To seek approval to extend three contracts, 91/92/95/95a (Tollesbury to Witham-Tollesbury to Colchester and Tollesbury to Maldon) SB10/11/13 (Moreton to Epping, Matching Green to Epping and Stanford Rivers to Epping) and SB 12 (Toot Hill to Harlow) expiring in March 2020. By extending these contracts to July 2020 will bring them in line with all other Monday to Saturday daytime contracts

To seek approval to consult on the withdrawal of two contracts for services 39 Witham Town Centre to Allectus Way and 313/313a Great Dunmow to Saffron Walden as these are both over £10.00 per passenger journey which significantly exceeds our benchmark cost per passenger journey of £5.00.
