

# Public Notice Appendix A

## Safer, Greener, Healthier Routes in Brentwood – temporary measures

**NOTICE IS HEREBY GIVEN** that from the date specified below, the Essex County Council has temporarily introduced the following measures under Section 14(2) of the Road Traffic Regulation Act 1984, as amended (the Act), in the interests of public safety and social distancing due to coronavirus.

### **Bus Gate 9am to 6pm**

*Local Buses and Pedal Cycles Only*

**A1023 High Street** In a westerly direction from its junction with A128 Ingrave Road.

**A1023 High Street** In an easterly direction from its junction with Kings Road/Weald Road.

**All waiting, loading and parking bays on A1023 High Street between its junctions with A128 Ingrave Road and Kings Road/Weald Road are suspended.**

### **No Entry except Pedal Cycles**

**A1023 High Street** No entry into A1023 High Street from Crown Street

### **Banned Left Turn except cycles**

**St Thomas Road** No left turn from St Thomas Road, into A1023 High Street

### **Suspension of existing One Way Restriction**

**Crown Street** From its junction with Hart Street, to its junction with A1023 High Street

**Hart Street** From its junction with Kings Road, to its junction with Crown Street

### **Suspension of Payment Parking Monday – Saturday, 8am – 6pm**

**Kings Road**  
(south west side) From a point approximately in line with the property boundary of Nos. 29 & 31 Kings Road, south east to a point 1 metre south east of the south eastern property boundary of No.51 Kings Road.

### **Suspension of Limited Waiting Monday-Saturday, 9am-6pm, 20 minutes, No Return Within 2 Hours**

**Hart Street**  
(north side) From a point approximately 45 metres west of its junction with Crown Street, west for approximately 10 metres.

**Hart Street**  
(north side) From a point approximately 60 metres west of its junction with Crown Street, west for approximately 6 metres.

**Hart Street**  
(north side) From a point approximately 20 metres east of its junction with Kings Road, east for approximately 18 metres.

**Suspension of Limited Waiting Monday-Saturday, 9am-6pm, 30 minutes, No Return Within 4 Hours**

**St Thomas Road**  
(north east side) From a point in line with the property boundary of Nos. 4 & 6 St Thomas Road, south east for approximately 60 metres.

**Introduction of Disabled Badge Holders Only**

**St Thomas Road**  
(north east side) From a point in line with the property boundary of Nos. 4 & 6 St Thomas Road, south east for approximately 60 metres.

These traffic measures are undertaken under “the Act” and in conjunction with additional safety improvements are funded by national government as part of the response to the Covid-19 situation, designed to allow people more space to social distance as people move around the town centre. The Traffic measures under this 21 day notice may stay in place or be amended by a further 21 day notice and if successful may be extended for up to 18 months by virtue of an order made under section 14(1) of “the Act”.

Essex Highways will start to install on-street temporary measures including barriers, signs and cones, on routes in the town centre from **3 July 2020**, in support of non-essential retail business.
